In the Name of God. Amen I Jesse Brooks of the County of Christian and State of Kentucky being sound in mind and memory (thanks be to God for his mercy) have thought it necessary knowing the uncertainty of human life to make this my last will & Testament in manner and form following.

1st. My — I do my will and desire that all the money due me be collected and all my lawful debts paid and that each one of my heirs shall pay an equal part.

2. I do hereby give and leave to my son William H. Brooks for his use and benefit forever four hundred and fifty acres of land off of the lower end of the tract on which I now live and also my Negro boys named Harry and a Negro boy named Young by his paying forty dollars a piece to each of my other children. Also my smooth tools and an equal part with the rest of my children of my Estate that may remain after the legacies hereafter be paid and after the death of my son William it is my will and desire that all the above named property not disposed of by my son William shall go to his children. Also I give unto my son William H. Brooks one Negro girl named Lucy as he bought her of my daughter Lucy and paid her for the same.

3. I do hereby give and leave to my grandson son Jesse Thos. a Deaf Dumb the tract of land adjoining the place from which I have sold John Pindilton containing two hundred acres also my Negro Boy named John B. one horse black one hundred dollars & I desire that my said grandson shall have and receive of my son William one good big, good and close bodied coat if he lives to be of age but if my grandson should die without issue it is my will and desire that all the property I have left him as above shall be equally divided amongst my children and it is further my particular desire and request and I hereby direct that my said grandson shall remain in my house and that all the property I have left him as above together with his clothing shall be entirely under the direction and control of my daughter until he becomes of age.

4. I do hereby give and leave unto my daughter Betsey Brooks for her use and benefit during her life all the remainder of my Estate including my clothing house &c. &c. &c. the whole ends of the tract on the same name as also my Negro boy named Harry also his bed and furniture &c. &c.
