In the name of God, Amen: I Frances Burrows of the State of Kentucky and County of Christian being in perfect sense, and not knowing what shall please Almighty God, to call me hence, doth hereby make and ordain this my last will and testament: First, I leave after my decease that my three sons Thomas Burrows, William D. Burrows and Roger Burrows be paid by my Ex^{rs} hereafter named the sum of four hundred dollars to be equally divided between them if Frank (a negro man who is now run away) should not be got again before my decease.

Secondly, I desire that the sum of twenty pounds current money be paid to my son-in-law Andrew Struble & his heirs forever.

Thirdly, I desire that the balance of my money, which is sixty pounds be equally divided between my two daughters Sally Struble and Pansy J. Burck, & their and their heirs forever.

Fourthly, I give and bequeath to my dear daughter Sally Ellen Burrows, daughter of my son Roger Burrows one father bed and furniture to her and her heirs forever.

Fifthly, I give and bequeath to Joseph H. Miller Burroughs, the son of Nathaniel Burrows one father bed and furniture to him and his heirs forever.
