Abner Jonathan Bogaart dec'd

As ordered to order of the County Court of Christiana Co.
directed at March Term 1823 to settle the accounts of
A Hardwick Guardian for the Infant heirs of Abner Bogaart dec'd
being first shown and the Guardian being sworn to support as follows
We find that on a final Settlement between James Payne Executor
of Abner Bogaart and William A Hardwick, there appears to be
due to the Infant heirs of said Bogaart from the sale of the personal
Estate \$104.36 1/2 to each heir, with interest from 7th Nov 1821
also we find that the land of said Bogaart sold for \$5000 less
the 5th of Dec 1822, which is to be divided among eight legatees
