In the name of God Amen Knowing that all men have to die I being of sound mind and memory do make this my last will and testament revoking all others that I may have heretofore made if it is my will that all my just debts and funeral expenses be paid give unto the heirs of my wife and to her I settle one dollar unto my brother Peter H. Stockton one dollar unto Schobed I Parish my rifle gun and powder horn unto James I Donly son of Sally & William I Donly my gray mare and I do hereby appoint my brother Samuel Stockton a trustee for the persons hereafter named and after my death it is my will that my brother Samuel Stockton shall take all the property both real and personal I may be possessed of into his possession in trust for the heirs of John Parish the heirs Elizabeth Stuart the heirs of James H. Taylor and the heirs of James I Donly and it is my will that my brother Samuel Stockton shall keep the whole of the aforesaid property in his possession in trust for the aforesaid heirs as long as he lives and after his death it is my will that the heirs above named shall have all the property with the increase or interest the property both real and personal I may justly have acquired provided my brother Samuel Stockton should never marry but if my brother Samuel Stockton should marry and have a legal heir or heirs then it is my will that none of the aforesaid property or any part thereof shall descend unto the aforesaid heir but all the property real and personal of every description that I may be possessed of shall descend to and be the property of the legal heirs or heir of my brother Samuel Stockton with all the increase and interest of the same in writing hereof I have set my hand and seal this 9th day of June 1827
