I William Howard of the County of Davis and State of Kentucky being law in health but sound in mind do make this my last will and Testament first I desire that all my just debts be punctually paid second I ~~wish~~ desire that my woman slave Phoebe remain in the hands of my beloved wife Ann Howard with her bed and furniture until my son Wm Howard shall be twenty one years of age then desire that my whole Estate shall be paid over to him. Except two hundred dollars to be given my son James Howard out of the Robson Note as soon as collected. I desire that my three first children by my abandoned Berdett Howard Elizabeth John and Ezra Howard to have full power to obtain my part of their Grand Father's Estate given me by their Grand Father also five dollars each of my present estate. I desire that my land shall be rented until my son comes of age. all my personal Estate sold and my son James and William, succeed ~~after~~ should dealt upon in their lawful heirs. I appoint Barlett Bustine my administrator this 16th -

Believing that my mortal life is about to come a close and being in my rational and proper mind I feel it a duty to dispose of my little estate in that way that doth seem to just and right. Accordingly I make and consent unto the following will. I cheerfully resign and commend my spirit unto the Lord who gave it. I will and desire that my body decently entred and that after all my just debts are paid the remaining portion of my property including the tract of land on which I reside be held and possessed by my wife Sally during her natural life and at her death I will desire that my son Henry Austin be Allowed to keep the said tract of land by paying to each of my children or legal heirs fifty one dollars amounting in all to two hundred and Eighty two dollars. Except my daughter Sarah Reeves unto her he is only to pay five dollars which is the full amount I desire her to have out of my estate. I also will and desire that my son Henry live with and support my wife during her life on said land and that he keep and support my son Marion and daughter Lucy and Grand daughter Sicidions Austin until they get enough to act and provide for themselves but if he fails to support my wife and children during the time heretofore named he shall lose the privilege of holding said land on the above named terms and shall come in only for his proportional part of the amount that said land may sell for at my wife's death, such is my will and Testament.
