I Martha O Thomason in full view of the uncertainty of life and the absolute certainty of the dissolution of soul and body Being of sound mind and possessing rational and disposing memory do make and enact this to be my last & only will and testament hereby revoking all and every other before made, to wit:

Item 1st I give into the hands of the Creator of all flesh my soul and body which are his, and from whom they originated. Believing that in the resurrection of the last day He will give unto me the everlasting life.

Item 2nd I wish to give unto my sons and do hereby give unto them out of my estate each a horse & saddle.

Item 3rd I give and devise the remainder of my estate to my children James J. Pascal J. William H. & Nelson my sons previously referred to and Mary Ann, Milley Archer and Martha Day, and if any of them should die before receiving their respective portions as designated in the foregoing clauses; then in that case it is my wish that the surviving children above named should inherit the portion assigned unto them respectively. Unto my daughter Frances B. May and my two grand daughters Prudence R. and Archibald Johnson each the sum of one dollar. In testimony whereof I have hereunto set my hand Sept. this 21st day of May A.D. 1839
