I will that the balance of my property belong to my wife Elizabeth Hunsford during her natural life or widowhood and at her death or marriage it to be equally divided between my children to wit Paddy Ann Hunsford Mary Jane Hunsford William Thomas Hunsford Rebecca Josephine Hunsford Elizabeth Hunsford and should there be any unborn to share equally with the above named and lastly I do hereby constitute and appoint my friend Robert Barnhill executor of this my last will and testament by me heretofore made.

I Jonas Little knowing that life is uncertain and full that I must depart soon out of this world, and being blessed with some of the things of this world desire that before my departure and while in my proper mind to make some disposition of them therewith my last will and testament, I desire that all of my Just debts shall be paid and that my remains shall be buried in a plain & decent manner after which I will and desire that my beloved wife Elizabeth Little shall have the farm whereon I now reside during her lifetime with fifty dollars and one horse one bed and bedding and my two young negroes Bill & Caroline the foregoing articles I reserve to dispose of as she pleases during her life at her death it is my desire that they shall all be sold and equally divided among all my living children except Martha Walling, at her death I desire her part which I desire to be equal with the rest of my children to go to her children I also desire that an equal part of all my property be given to John Mosley children by my daughter Mary I desire that my old woman Kessiah at my death shall be sold and that some one of the children shall buy her and take good care of her I further will & desire that all my property aside from what has been named shall be sold at my death (and as I have done something for all my children I deem it unnecessary to designate any particular portion to any one of them I therefore will and desire that all to secure an equal share of what is now left In testimony whereunto I set my hand and seal done this 13th day of May 1849
