perfect and disposing mind and knowing the uncertainty
of life and the certainty of death do make this my last
will and testament.

First, I bequeath my soul to him who gave it and
my body to the earth.

Second I devise all my just debts to be fully paid
Third I give to my beloved wife Margaret Walston all of
my property of every kind and description to her
during her life and at her death to descend and belong
to my children subject always to the payment of the sum
of about four hundred and thirty dollars which is in
my hands as Guardian of my stepson James M. Emery.

Fourth I hereby constitute and appoint my beloved wife
Margaret Walston my executrix to this my last will and
I also appoint my brother John Chalton my executor to assist
my beloved wife in the discharge of the duties which
will devolve on her as executrix.

Fifth I devise my said executrix to sell such of the
stock of Horses or Wagon & such other things as may be
deemed best to be sold privately or in such manner
as my Executrix & Executor may think best.

I Amos Ashby being afflicted in body but
sound in mind do make and constitute this my
last will and testament in the words of figures
following to wit,

Item 1st I wish all my just debts ~~paid off~~
2nd I wish given to my children as they married off
an equal portion of property except Sally whom
I have now with me than the others by \$25.00 I wish
her to have the sum of \$25.00 paid to her by
my Executors whenever it is most convenient.

3rd It is my wish and desire that the whole of the property
I am possessed of both real and personal be and remain
in the possession of my beloved wife Hannah Ashby and at
her death to enable her to raise and educate my young
children and when any of them become married they are
to have the same amount of and kind of property that
my present married children have had that is to say one
horse best work \$50.00 one bed, bedstead and furniture
one Bureau one Cow calf and inasmuch as Nancy
Thomas has not received her Bureau bed &c it is my
wish that she have them.

4th It is my wish and desire that my executrix to
sell the Plantation on which I now live and purchase
another if they think proper.

5th It is my wish that my daughter Susana who is
unable to take care of herself shall remain with her
mother and receive her support out of the estate should
she outlive her mother then and in that case she is
to be supported out of my estate.

6th Should my negro man Vincent or negro woman
Candice die in such a way as to render it necessary
to sell either of them I do hereby authorize my executor
or executors and apply the proceeds to the purchase of
other negroes and let the death of my beloved wife then
should be any unmarried children they shall have
the same property allotted to them that the married
children have had.

7th It is my wish that at the death of my beloved wife
that all my property be sold and equally divided between
my children except Stephen Ashby who has had 100 acres
of land worth \$300.00 and should there be the same
amount for each child they are to have it but if there
should not be as much for each Stephen must pay
to each as much as will make theirs equal to his
8th I do hereby appoint my beloved wife Hannah
Ashby my executrix and my son Stephen my
Executor to carry this my will into effect and having
