make and declare this my last will and Testament
as follows (words) I give to my son William Plummer
five Shillings current money of the State
apd. and no more. Also I give to my son
Abraham Plummer five Shillings current
money as apd. and no more.

Also I give to my three grand Daughters
the Children of my son Isaac Plummer Decd.
(Vanda Swannah Plummer Mary Plummer
and Reuben Plummer) five Shillings current
Money as apd. Also I give to my Daughter
Mary Borey etty Wife with the
accomplishments thereto belonging and no more
Also I give to my Daughter Sarah Borey five
Shillings current money as apd. and no more

Also I give to my Daughter Elizabeth Bump
five Shillings current money as apd. and
no more. Also I give and bequeath to my
Wife Sarah Plummer one third part of
all my Land (cont) the lot no two and
no three whichon myself and my son
Jacob Plummer now live by her duty to be
supported and enjoyed during her natural
life Also I give to my wife apd. one third
part of all my moveable Estate after my
Debts are paid and my Funeral expenses
are paid. Only I give to my son
Benjamin Plummer all my

Woods and my young boy man which will be three
years old this Spring. Also I give and bequeath
to my son Jacob Plummer and Benjamin Plummer
all my Land to me belonging either in Law or Equity
or otherwise howsoever In Lots &c two And third
apd. (Jacob the place where he now live, and Benjamin
the place where I now live to be Divided Equally between
them by and or more time to the best Advantage
that may be to Accomodate Each one to them
and their Heirs forever. Also I give and bequeath
all the Remainder of my personal Estate not
already disposed of to my five Daughters Among
them or the surviving part of them to be Equally
Divided among Priscilla Plummer Prancy Plummer
Rachel Plummer Dinetta Plummer and Lucy
Plummer And lastly I nominate constitute and
appoint my two son Jacob Plummer and Benjamin
Plummer Sole Executors of this my Last Will and
Testament. In Witness Whereof I have hereunto

hundred and four.
