In the name of God, I, Samuel B. Bouter, do hereby
counter of the County of Fleming & State
of Kentucky being in every imperfect state
of health, but of perfect mind & memory
thanks be given to God: and calling to mind
the mortality of my body, knowing it is appointed
unto all men once to die do make and give
and appoint this my last will and Testament
that is to say principally and first of all
I give and recommend my soul into the hands
of almighty God who gave it and my body
I recommend to the earth to be buried in de-
cent christian burial at the discretion of
my Executors nothing doubting but at the general
resurrection I shall receive the same again
by the almighty Power of God. And as touching
such worldly Estate wherewith it has pleased
God to bless me in this life I give devise &
dispose of the same in the following
manner and form. First I give & bequeath
unto my beloved wife Margaret Bouter all
my real estate until my youngest son
Samuel B. Bouter becomes of age in order that she
may discharge a debt I owe in the Common
wealths Bank, and when said debt becomes paid
the two thirds of the profits arising from my
landed Estate is to be equally divided between my
three sons Tho. Bouter, Robt. A. Bouter & Samuel
B. Bouter my wife is to have the other third of
my real estate for during her natural life at the
expiration of which my land is to be equally divided
between my before above mentioned three sons
Thomas, Robert A. and Samuel B. Bouter. I
