We, John G. Reffett, and Sarah Reffett, of Pyramid, Floyd County, Kentucky, being of sound and disposing mind and memory, do hereby make, declare and publish this to be our last will and testament, hereby revoking any and all prior wills by us made.

ITEM 1. It is our wish that first of all, our debts, including funeral, burial and medical expenses of our last illness and death be paid as soon after our decease as possible.

ITEM 2. We give and bequeath unto our grand son, Robert Reffett as his entire share of our estate, individual, joint, personal and real, the following described property to wit:

Beginning at a post, a corner to lot No. 9 in division No. 1; thence, an East course to center of Creek; thence a North Course with the creek to opposite the Buckeye; thence a West course to a marked Buckeye at the mouth of a drain; thence with a drain to an Elm in the drain; thence leaving the drain up the hill to an Elm; thence a straight line to a poplar; thence to an apple tree; thence to an Ironwood; thence same course to a Black Oak; thence to a Locust; thence to a Somersrod and post near the fence to Columbus Prater's line; thence an East course down the point with Tom Prater's line and Eddie Howard's line to a Black Oak stump; thence same course to a marked Sassafras; thence same course to a stake on the point, a corner to lot No. 9; thence a straight line to a marked Basket oak; thence a straight line to a post at the beginning.

All the rest and residue of our estate, both real and personal, we devise, bequeath and give unto our children, H. H. Reffett, W. M. Reffett, Whiteman Reffett, Malcolm Reffett, and Omaha Reffett Ousley, and to our grand child, Edna Mae Castle, she being the only daughter of our deceased daughter Fella Reffett Castle, each and all of said children and grandchild to share and share alike in our estate in accordance with the laws of descent and distribution of the state of Kentucky.

It is our will and wish that in case Robert Reffett should die without leaving surviving him and children of his own body that then the property herein given unto him should revert back to us, or either of us, if living, and if we be dead, then it shall revert back to our surviving children at that time.
