

I, RILEY REYNOLDS, of Harold, Ky., being in sound mind, but not feeling right good, in body, and being 74 years old, make this as my last Will and Testament. I have two farms, one near Harold, Ky., & one near head of Big Mud Creek.

First, I wish all my just debts and funeral expenses to be paid. I hereby give to my son, Joe Reynolds, the farm and all rights thereto at or near Harold, Ky. I have two grandsons, one named Walter & the other named Waltus, I give to them the farm in or near head of Big Mud Creek, and I divide it as follows: To Waltus, his tract described as follows, being on Big Mud Creek. Beginning at the mouth of the land; thence up the branch to a walnut tree; thence straight line to a small white oak on the point; thence straight up the point with near center of same, to the top of the hill; thence around the hill with the top thereof to Joe Reynolds line and his line to the creek; thence down the branch to the beginning. The balance of said land is hereby willed to Walter Reynolds. There is a gas well on the part willed to Waltus and about 84 acres of coal, willed to Walter on his part.

The gas is to be divided equally between the two and said Waltus & Walter are to own all the minerals jointly, on said tracts.

I own some gas rights on Big Mud Creek & Clear Creek. I hereby will the right to my son, Joe Reynolds & my two grandsons, Waltus & Walter. Joe to own one half & the two grandsons the other one-half; they may have developed and they may sell to each other or jointly to any one. I have a cow & team of mules, my wife, Nannie is to have the cow, and I appoint my son, Joe Reynolds to sell the mules and have the money to become part of my estate. I have a note on Jerry J. Boyd, \$2000, and about \$500 in money in Bank.

I hereby appoint Joe Reynolds, as a committee to collect said note, and to take charge of the money in bank and to pay all expenses of funeral and hold the balance and from time to time pay some of it to my wife, Nannie, as it may appear she need it. Any remaining shall go to son, Joe Reynolds, & grandsons, Walter & Waltus; 1/2 to Joe & 1/4 each to grandsons.

My wife owns some land and has a daughter, and we have agreed that she give her land to her daughter.

My wife, Nannie is to have what she needs of the household good, and the checkens. All other matters, corn & other property is to be maised and administered by Joe Reynolds, and converted to the estate.
