

LAST WILL AND TESTAMENT OF E. F. FIELDS

I, E. F. FIELDS, of Martin County, and State of Kentucky, being of full age and of sound mind and memory do make, publish and declare this to be my last will and testament hereby revoking any and all wills by me heretofore made.

Item 1. I direct that all my just debts and funeral expenses be paid out of my estate as soon as practicable after the time of my decease.

Item 2. I give, devise, and bequeath to Amos Fields, my son, the sum of \$500.00, and also give, devise and bequeath to my daughter, Virgie Muncy the sum of \$500.00 and direct that said sums be paid to them out of the moneys remaining after my just debts and funeral expenses have been paid. This ~~account of their receiving no~~ bequest of money made to Amos Fields and Virgie Muncy is made to them on account of their receiving no share in the surface of the home farm.

Item 3. All the remainder of the money owned by me at the time of my death, after my debts and funeral expenses have been paid and after Amos Fields and Virgie Muncy have been paid \$500.00 each, all moneys then remaining are to be shared equally by the following children: Amos Fields, Kenis Fields, Albert Fields, Vina Kirk, Virgie Muncy and Elmer Fields.

Item 4. I give, bequeath and devise to my children, Amos Fields, Kenis Fields, Albert Fields, Elmer Fields, Vina Kirk and Virgie Muncy, to be shared equally among them all the minerals that I own under the following described tracts of land:

(a) All the minerals that I own under the home tract situated on the Meat House Fork of Wolf Creek, containing 443 acres, more or less.

(b) All the minerals that I own on a certain tract of land located on Little Rock castle Fork of Wolf Creek, which I bought from Wig Preece.

(c) All the mineral that I own under a certain tract of land that I bought from Dike Blackburn. Said mineral located on the Meat House Fork of Wolf Creek, in Martin County, and containing 100 acres, more or less, of oil and gas rights, and 25 acres, more or less, of coal rights.

(d) 37½ acres of oil and gas rights, situated in Pike County, Kentucky, on the Brushie Fork of Johns Creek, which I bought from Ben Blackburn.

(e) 30 acres, more or less, of oil and gas rights situated in Pike County, Kentucky, on the Spankum Fork of Brushie, which I bought from John Lowe.

(f) 203 acres, more or less, of oil and gas rights, on the Peter Cave Fork of Pigeon Roost in Martin County, Kentucky, and being the oil and gas rights under the land known as the W. W. Fields farm. I give, bequeath and devise to my children Amos Fields, Kenis Fields, Albert Fields, Elmer Fields, Vina Kirk and Virgie Muncy, all rentals and royalties which may accrue to the minerals that I own at the time of my death, to be shared equally among them.

Item 5. I give, bequeath and devise to my children, Amos Fields, Kenis Fields, Albert Fields, Elmer Fields, Vina Kirk and Virgie Muncy, to share equally, 60 acres, more or less, in fee simple which I own in Floyd County, Kentucky, known as the Tom McCoy tract situated on the Brushie Fork of Johns Creek.

Item 6. I give, bequeath and devise to my son, Kenis Fields, the following described tract of surface situated in Martin County, Kentucky, on the Meat House Fork of Wolf Creek, and

"Beginning at a stake at the side of the present county road; thence running across the bottom to a sycamore; thence crossing the creek and running by a big rock in the fields and on to the top of the knob on the ridge between Kenis Fields Branch and the Finley Fork; thence up the creek with the dividing ridge between the Finley Fork and Kenis Fields Branch to the line of a tract purchased by Albert Fields from Sam Muncy; thence with said line to the creek; Meat house fork; thence crossing the creek to the present county road; thence down the creek with the road to the beginning.

Item 7. I give, bequeath and devise to my son, Albert Fields, the surface described as follows:

Situated in Martin County, Kentucky, on the Meat House Fork of Wolf Creek, and

"Beginning at a stake at the side of the road which was also the beginning corner of the tract bequeath to Kenis Fields; thence running with the line of said Kenis Fields Tract across the creek and up the hill to the top of the knob upon a ridge at the Finley Fork; thence leaving the line of Kenis Fields and running with the center of the ridge toward McGee Branch to a high knob at the head of the branch where Albert Fields now lives; thence down the ridge between McGee Branch and the Branch where Albert Fields now lives with the center of the ridge to the top of the knob on the ridge between the Albert Fields Branch and the Branch where Frank Fields now lives; thence leaving the ridge and down the point with the center of the point to a stake; thence down to the fence and with the fence down the hill to a hickory just back of the house where Albert Fields lives; thence down the creek with the cross fence to the lower end of the bottom to a stake; thence to the creek; thence up the creek and crossing the creek to a stake in the present County road; thence with the county road to the beginning."

Item 8. I give, bequeath and devise to my daughter, Vina Kirk, a tract of surface described as follows:

Situated on the Meat House Fork of Wolf Creek, in Martin County, Kentucky, and described as follows:

"Beginning on a stake at the edge of the present county road at the lower line of Albert Fields tract; thence reversing the calls of his line and running back across the creek with his line to the top of the knob between Albert Fields Branch and the Frank Fields Branch; thence leaving Albert Fields line and turning down the ridge and running with the center of the ridge between Meat House and McGee Branch to a knob at the head of the branch at Harve Muncy's; thence down the ridge between the Home Branch, that is the Frank Fields Branch, and Harve Muncy Branch to a knob just back of where Frank Fields now lives; thence a straight line to a hickory at the upper end of a cross fence; thence down with the cross fence to the creek; thence down the creek and crossing the creek to a marked rock on the lower side of the present county road; thence with the road up the creek to the beginning."

Item 9. I give, bequeath and devise to my son, Elmer Fields, a tract of surface described as follows:

Situated in Martin County, Kentucky, on the Meat House Fork of Wolf Creek, and

"Beginning on a marked rock near the present county road on the lower line of a tract bequeathed to Vina Kirk and with her line reversing the calls thereof, and crossing the creek, running with the cross fence to a hickory; thence to the top of the knob; thence leaving Vina Kirk's line and turning down a point between Harve Muncy Branch and Meat House Fork to William Muncy line; thence down the hill with William Muncy line to a sycamore near the creek; thence crossing the creek to a chestnut; thence up the hill to a beach on top of the point; thence with the center of the point to the top of the hill; thence up the ridge to the top of the knob; thence down the hill to a high cliff; thence a straight line to a big rock on the upper side of the road; thence down the creek with the road to the beginning."

Item 10. I give, bequeath and devise the proceeds of one life insurance Policy of the face value of \$2,000.00 carried with the Bnkers Life Insurance Company, together with the accrued dividends thereon to my children, Amos Fields, Kenis Fields, Albert Fields, Elmer Fields, Vina Kirk and Virgie Muncy to be shared equally by them.

In the event that there is not sufficient money in my estate at the time of my death to pay the bequest of \$500.00 each to Amos Fields and Virgie Muncy at the time of my death as set out in Item 2 hereof, I direct that said bequest of \$500.00 each to Amos Fields and Virgie Muncy be paid out of the proceeds of said insurance policy and that then the balance of said proceeds be divided among my children equally as above named, to-wit: Amos Fields, Kenis Fields, Albert Fields, Elmer Fields, Vina Kirk and Virgie Muncy.

Item 11. All the rest and residue of my estate, both real and personal, I give, devise and bequeath to my children, Amos Fields, Kenis Fields, Albert Fields, Elmer Fields, Vina Kirk and Virgie Muncy, to be shared equally among them.

Item 12. I make, nominate and appoint my son, Amos Fields of Sprigg, West Virginia, and my son, Albert Fields, of Marie, Martin County, Kentucky, to be executors of this my last Will and Testament with full right, power and authority in order to pay all debts and all the legacies hereinafore given and in order to carry into effect all the provisions and purposes of said will
