I, Tobe Derossett, of Cliff, Floyd County, and State of Kentucky, being of full age and of sound mind and memory, do make, publish and declare this to be my last will and testament, hereby revoking all wills by me heretofore made, if any.

FIFTY: It is further my intentions in this will that the same be as heretofore stated, unless my said wife, after my death, remarries; then in that event my entire estate be divided as required by law, she holding only dower interest in the land, and each of the children to have equal shares in the same.
