

FIRST: We direct that all our just debts and funeral expenses be paid out of our personal estate as soon as practicable after the time of each our deaths, whichever of us departs this life first his or her funeral expenses must be paid out of our personal property or money on hands and the real estate herein-after described is devised and is effective only after both of our deaths, the one left living is to have control and possession of all our real estate and personal property until his or her death.

SECOND: All our real estate situated lying and being on Katy Friend Branch, a tributary of Middle Creek, Floyd County, Kentucky being the same lands conveyed to Polly Rose by J. N. Harris, Daisy Harris and Sarah Harris of March 19, 1908-Recorded in Deed Book No. 20 page 559 in Floyd County Court Clerk's Office and the same land conveyed to John E. Rose by Daisy Harris and J. N. Harris to John E. Rose of date October 11, 1916 and recorded in Deed Book No. 47 Page 76 in Floyd County Court Clerk's Office, and the same lands conveyed to John E. Rose by D. W. Spurlock and Jane Spurlock of date February 25, 1918 and recorded in Deed Book No. 55 Page 550 in Floyd County Court Clerk's Office.

This being all the real estate we now own and the same is hereby devised to our children and heirs as follows to wit:

TO BEN ROSE, a boundary or tract of land on Katy Friend Branch Floyd County, Kentucky Land beginnin on a maple on said Ben Rose's line running with the branch to the Water Gap, thence with the County Road to an Elm Tree; thence crossing the bottom to a white oak on the point and with the point to top of ridge, West Course, with the point to top of the ridge to Ben Rose's line, down the hill with said line to the Maple, the Beginning.

TO LEANDER ROSE, a boundary or tract of land in Katy Friend Branch Floyd County Kentucky - Beginning at Ben Rose's line running up the Branch with the County Road to Harry Cooley's line; thence up the point to McGuire's line; thence down the hill with said line to John E. McGuire's line and with John E. McGuire's line to Sarah Jane Elliott's line and with Sarah Elliott's line to Ben Rose's line and with Ben Rose's line to the beginning.

We are devising to Leander Rose an extra portion herein for services to us and for money he has given us and also that at our death that he, Leander Rose shall pay to Curtis Rose and Carl Rose, children of our son Joe Rose, deceased Ten Dollars (\$10.00) each.

To John W. Rose, a boundary or tract of land, beginning on a silver maple at our lower line running up the Branch with the Branch to Water Gap, and across the road and with the road to Lower corner of Bob Rose's garden, thence with the garden fence to a ravine, thence with the ravine to a crooked chestnut oak thence back down the point with our lower line to the beginning.

TO SARAH JANE ELLIOTT, a boundary or tract of land on Katy Friend Branch Floyd County, Kentucky beginning on the Stock Well running up the branch to head of same to a sharp point, straight line up the hill to the center of the Knob between Town Branch and Pinhook Branch, thence a west course to Ben Rose's line; thence down the point to lower edge of old road; thence to beginning with reasonable haul way to County Road by Leander Rose.

To Liddie McGuire (nee Rose) heirs, John E. McGuire and Lucy Meadows and Anna McGuire a boundary or tract of land on Katy Friend Branch Floyd County, Kentucky beginning near mouth of drain near the barn, east course up the drain to Harry Cooley's line and with said line to top of the ridge, thence a north course to Sarah Jane Elliott's line, thence down the hill with said line to the beginning.

TO JOHN E. MC GUIRE, a boundary or tract of land on Katy Friend Branch Floyd County Kentucky beginning at a stake at the mouth of a ravine just below the barn, thence east course to a stake; thence to a pine stump; thence down the hill to McGuire line to branch; thence to the beginning.

This is for services John E. McGuire has rendered to us and may render hereafter.

To Bob Rose, a boundary or tract of land on Katy Friend Branch Floyd County, Kentucky, beginning at lower end of his garden with the County Road at a stake opposite a ravine; thence a south course with ravine to top of ridge, east course with said ridge to our lower line, thence down hill to John W. Rose line; thence e with said line to the beginning. We are living Bob Rose house and Garden for alding and assisting us ever since he was married.

TO MOLLIE GREEN nee ROSE, a boundary or tract of land on Katy Friend Branch Floyd County, Kentucky, Beginning at Bob Rose's line south course with said line to top of the ridge, thence an east course to Harry Cooley's line; thence down the hill with our upper line to County road and with County Road to the beginning.

THIRD: We have from time to time made advancement to our son Joe Rose, deceased, which in all is an amount sufficient for his part out of our estate, and for this reason do not devise or give him or his heirs any part of our estate either real or personal except that Leander Rose shall pay at our death to his sons Curtis Rose and Carl Rose Ten Dollars (\$10.00) each.

FOURTH. In the event that we should have any personal property or estate left after paying our funeral expenses and debts, our administrator shall dispose of same as required by law and pay the balance of the net proceeds to our children and heirs at law, except to the children of Joe Rose deceased.

FIFTH, We make, nominate and appoint our son Ben Rose to be our ADMINISTRATOR OF THIS our LAST WILL AND TESTAMENT, and request that no bond be required of him as such. We further request that no inventory or appraisement of our estate be made or taken in so far as the same may be lawfully omitted.
