1: I will that out of my estate my funeral expenses and just debts be first fully paid and satisfied.

2: I devise to my daughter, Maude C. WILL.

I, Grant Weddington, of Banner, Floyd County, Kentucky, being of full age and of sound mind and memory, do make publish and declare this to be my last will and testament, hereby revoking any and all wills by me heretofore made.

ITEM 1. I direct all my just debts and funeral expenses be paid out of my estate as soon as practicable after the time of my death.

ITEM 2. I give and bequeath to my wife, Nannie Weddington,

during her lifetime, all of my entire estate, both personal and real. She may dispose of any personal property I may have but she shall not sell or dispose of the real estate. But she is to have possession of the real estate, and all rents and profits arising therefrom either from the gas or other products including coal and all other things arising from said real estate.

ITEM 3. At the death of my wife, I direct that her debts and funeral expenses be paid out of my estate and the remainder of the estate be divided as follows:

I direct that all of my real estate be equally divided between my three boys, Alexander Weddington, Grant Weddington, Jr., and Johnnie Weddington. I direct that each of my eight daughters be paid out of my estate the sum of Seventy Five dollars. That is Susan Akers, Gracy Hulett, Myrd Stephens, Kate Conn, Jessie Weddington, Ines Weddington, Maxie Weddington, and Lucy Jane Weddington, each be paid (\$75.00) Seventy Five Dollars.

If my wife Mannie Weddington wishes to, she may pay any one or all of my daughters the \$75.00 going to them or either of them and take their receipt for same and they will have no other charge against the estate. But she will not be required to pay any one of them any thing during her life unless she sees fit.

ITEM 4. If my wife Mannie Weddington, is living at the time of my death and when this will is probated, I make, nominate and appoint her to be the Executrix of this my last will and testament, and she shall not be required to execute any bond in this behalf, or held responsible for any of the property she receives in this behalf.

I also Will and Bequeath to My Daughter Lydia E. May, the Big Bed.

I Also Will and Bequeath to my Daughter, Ollie J. Layne, One (1) Dresser, and the One Hundred and Twenty Five Dollars, (\$125.00) in Cash that she Owes Me.

I Will and Bequeath to my Son, Don B. Bush, the One Hundred Dollars, (\$100.00) in Cash that he Owes Me, a One-Half (1/2) interest in my Wagon and the Family Clock.

I will and Bequeath to my Son, J. Cecil Bush, the One Hundred Dollars, (\$100.00) in Cash that he Owes Me, a One-Half (1/2) interest in my Wagon and the Little Bed.
