PARAGRAPH I.

PARAGRAPH IV.

Heinze, be permitted to qualify as executrix under this, my last will and testament without the execution of bond and without the filing of an appraisal of my property. Should my beloved wife pre-decease me, then I desire that T. A. Johnston, Welch, W. Va., be appointed as executor of my estate who will execute bond in an amount equal to the funds that will be coming into his hands as such executor and administer my estate until my children, respectively arrive at their majority at which time said executor shall settle with my said children when and as they reach their majority, respectively.
