

SEVENTH: If my husband, Henry Ley, shall predecease me and any of my children shall have died before my death, leaving to survive him or her a spouse, I give to such spouse the household furniture and other articles provided for such child by paragraph Third hereof and the sum of one Hundred (\$100.00) Dollars. The balance of the share heretofore provided for my said child shall be given to his or her children, but if there shall be no such children surviving my child or children at that time, then the balance shall be divided equally between my other surviving children or their issue.

EIGHTH: If any devisee or legatee under this my Last Will and Testament shall be dissatisfied with the provisions hereof and shall attempt to or institute proceedings of any kind to contest or in any other manner change this my Last Will and Testament, such devisee or legatee shall forfeit any and all interest herein provided for, and to said person or persons I give and bequeath the sum of Ten (\$10.00) Dollars to each in lieu of any and all interests or shares of my said estate.

NINTH: I nominate, constitute and appoint my said husband, Henry Ley, to be Executor of this my Last Will and Testament; and in case he should predecease me I appoint Earl Suckles and my son, Herbert L. Ley, as joint executors, and I further request that the executor or the joint executors of this my Last Will and Testament shall serve individually or jointly without bond.

LAST WILL AND TESTAMENT

I, HARRY N. COOLEY, of Prestonsburg, Kentucky, being of full age and sound and disposing mind and memory, do hereby make, publish and declare this to be my last will and testament, hereby revoking all wills heretofore by me made.

ITEM I.

I direct that all my just debts and funeral expenses be paid out of my estate as soon as practicable after the time of my death.

ITEM II.

I made a gift to my daughter, Emma Marshall, consisting of a tract of land located on the Mutton Fork of Bull Creek in Floyd County, Kentucky, of the value of Five Hundred (\$500.00) Dollars, and I direct that the conveyance for said tract of land by me to her be considered as an advancement, and shall, by my executors, be charged against her, and she shall receive nothing from my estate until each of my other children have received from my estate the sum of Five Hundred (\$500.00) Dollars each.

ITEM III.

I made a similar gift to my daughter, Ruth Meade which she was required to sell because of her husband's sickness and physical condition, and for that reason I direct that said gift shall not, in any manner, be deemed as an advancement to the said Ruth Meade, or be counted, in any manner, in the settlement of my estate.

ITEM IV.

Subject to the provisions of Item II, I devise, give and bequeath all the property, both, real, personal and mixed, of every kind, wheresoever situated, which I may own or have the right to dispose of, to my seven children: Julia Cooley, Emma Marshall, Mae Laddy, Ruth Meade, Otis Cooley, W. R. Cooley and Orville Cooley, but the advancement, mentioned in Item II, shall be deducted from the part of my estate devised to my daughter, Emma Marshall.

ITEM V.

I make, appoint and nominate my two sons, Otis Cooley and Orville Cooley my joint executors of this, my last will and testament, and in the event one of my two sons dies before I do, the survivor shall exercise the powers of said office, but if they each survive me both of them shall jointly serve as the executors of my estate.

I further request that no bond be required of said executors, or either of them, and that no inventory of my estate be made.
