I, J. M. Hall of Beaver, Floyd County, Kentucky, being of full age and sound mind and memory, do make publish and declare this to be my last will and testament, hereby revoking all wills by me heretofore made.

Item 1. I direct that all my just debts and funeral expenses be paid out of my estate as soon as practical after the time of my decease.

Item 2. I give and bequeath to Charles Little and Mary Little, all the household furniture, books, pictures, and all other household effects which shall be in and about my residence at the time of my decease.

Item 3. I give and bequeath to Charles Little and Mary Little the real property or what is commonly known as the "home-place", including the dwelling and garden located on Tackett's Fork of Mud Creek in Floyd County, Kentucky.

Item 5. I give and bequeath to John L. Little the real estate on the left-hand side of Baldrige Hollow, located on Tackett Fork of Mud Creek in Floyd County.

Item 6. I give and bequeath to Ruth Little and Naomi Little, each a one-half share of the real estate on the right hand side of the road on Tackett Fork of Mud Creek in Floyd County, Kentucky.

Item 7. I give and bequeath to Clarence Osborne and Geneva Osborne the real estate and house where they now live as far down as the barn and I give and bequeath to Charles Little and Mary Little the remainder on the left side of the road located on Tackett Fork of Mud Creek in Floyd County, Kentucky.

Item 8. I give and bequeath to each legatee or devisee in this will the rights to the coal, oil and gas and any other mineral rights in and under the real estate given and bequeathed to each respective one herein, in other words each is to own the mineral rights under the land allotted to them in this will.

Item 9. I give and bequeath to Charles Little and Mary Little all the coal and other minerals that I own and the mineral rights to same that I own or may later own in and under the land of Hatler Tackett.

Item 10. I give and bequeath to Charles Little and Mary Little the 49 Hudson car that I own.

Item 11. I give and bequeath to Charles Little and Bertha Little the money I have in The Bank Josephine at Prestonsburg, and all the other money that I may have at the time of my decease, a one-half share to each and all the residue of my estate, real and personal, of every kind and description, where-so-ever situate, which I may own or have the right to dispose of at the time of my decease, I give, bequeath and devise to Charles Little and Bertha Little, a one-half share each, absolutely and in fee simple.

Item 12. I make, nominate and appoint, Charles Little and Bertha Little as my Co-executrix of this my last will and testament and I request that no bond be required of them as such. I further request that no inventory of my estate be made or taken in so far as the same may be lawfully omitted.
