 I John Setser of Johns Creek, Floyd County
 Kentucky being now 74 years of age of sound
 mind & disposing memory & knowing that life
 is uncertain and death is certain, make this
 my last will and testament to wit
 Item 1st. I will bequeath to my son Elijah
 B. Setser the following tract or boundary of
 Land and being on the waters of Johns Creek
 in Floyd County Ky. and being same now
 occupied by me, viz. Beginning at an
 Elm tree on the lower side of the road
 about 50 yards from my residence thence to
 and running with the lower side of the
 lane a Northeast course to the top of the
 ridge thence a North course to the high knut
 to the line of Sinkhams claim, thence an
 East course to the middle field gap to
 Mary Setsers line thence a straight line
 down to the branch road with the Morgan
 Setser line to a dog vault in the field
 thence a South course and a straight
 line to the top of the hill and with the
 Morg Setser line, thence a West course
 & down the center of the Point to the
 foot of same and with the Morg
 Setser line thence a straight line and
 with the Morg Setser line to a Horn
 beam on the bank of Johns Creek and
 with the meanders of same to opposite
 the Elm tree first herein mentioned, thence
 a straight line to the Elm tree the place
 of beginning. I also will and bequeath
 to my son Elijah B. Setser all my per-
 sonal property that I may be the owner
 of of my designation but it is understood
 that I name the right to use and
 occupy the lands here before mentioned so
 long as my self and wife shall live also
 all the personal property &c at the death of my
 wife Polly Setser and my self both the
 real and personal estate here in before
 mentioned is to go to the said Elijah
 Setser and his heirs.

Item 2nd. Having heretofore given
 to my son Alfred Setser lands
 on Saunders Creek worth two hundred

Dollars is all he is entitled to out of
 my estate except the sum of ~~one~~ ^{one}
 dollar which my executor hereafter named
 will pay to him out of my personal
 estate
 Item 3rd. Having here before given to
 Henry Morgan Setser lands on the upper
 end of my farm (\$200 worth each) is
 all that I intended them to have out
 of my estate except the sum of one
 dollar each which I desire my
 direct my executor hereafter named to pay
 to pay to Henry Setser one hundred dollars
 and to the heirs of Morgan Setser one dollar
 out of my personal estate.

Item 4th. Having heretofore given to my
 son William Jackson Setser lands on
 the lower end of my farm worth \$500
 this is all that I intend for him to have
 out of my estate except the sum of one
 dollar which my executor hereafter named
 will pay him out of my personal estate.

Item 5th. It is my will that my executor
 hereafter named pay to my daughter Martha
 (line wife of Jacob line) the sum of one
 dollar out of my personal estate. Having
 heretofore given to her through my boys the
 sum of \$5000 which said amount is all
 that I intend her to have out of my estate.

Item 6th. It is my will that my executor
 hereafter named pay to Elizabeth Ward (wife
 of Alia Ward) the sum of one dollar out of
 my personal estate. Having heretofore
 given to her through my boys the sum
 of \$5000 which said amount is all
 that I intend her to have out of my estate.

Item 7th. Having heretofore given to
 my daughter Marguerite Wells through
 my boys the sum of \$5000 this is all
 that I intend her to have out of my estate.
