LAST WILL AND TESTAMENT OF
LIDA RICHMOND COTTRELL

I, LIDA RICHMOND COTTRELL, of Prestonsburg, Floyd County, Kentucky, being over twenty-one years of age, of sound mind and memory, do make, publish and declare this to be my last will and testament, hereby revoking all wills heretofore by me made.

ITEM 1. I direct that all of my just debts and funeral expenses be paid out of my estate as soon as practicable after the time of my decease.

ITEM 2. I will, devise and bequeath to my daughter, Inez C. Hobson, my brick home where I now live, which is located on the east side of First Avenue in Prestonsburg, Kentucky; also the piano, all personal property and all furnishings located in said home and my said daughter is to divide said personal property as she may see fit. Said real estate so devised to my said daughter is bounded and described as follows:

"BEGINNING on First Avenue at the intersection of First Avenue and Fourth Street and on the Northwest corner of said intersection; thence along the Northern side of Fourth Street 14.5 feet to a stake; thence on a line parallel with First Avenue 73 feet and 4 inches to the line of Susan Felphrey; thence with Susan Felphrey's line 14.5 feet to First Avenue; thence along First Avenue in a Southeastern direction 73 feet and 4 inches to Ford Street, the place of beginning."

Being the same property conveyed to Lida Cottrell by Isaac Richmond and Mary R. Richmond, his wife, by deed bearing date January 10, 1906 and recorded in Deed Book No. 14, Page 520, Floyd County Court Clerk's Office.

ITEM 3. I also will and bequeath to my daughter Inez C. Hobson, the cottage house located on Ford Street in the City of Prestonsburg, Floyd County, Kentucky, where Ray Stephens now lives.

The Division line between this property and the brick home property shall be a straight line running from the Ford Alley Back with the lower side of the run-way of the garage and to the back of both lots. This lot is described as follows:

"BEGINNING at the edge of the Ford Alley; thence running back a straight line with the edge of the garage run-way nearest the cottage house and a straight line on back to the back of the lot; thence across the back end of the lot to the Inez R. Hereford lot; thence with Inez R. Hereford's lot back to the Ford Alley; thence with the Ford Alley back to the beginning, so as to include the lot on which said Ray Stephens now lives."

ITEM 4. I give and bequeath to my grandson, Frederick Richmond Cottrell, the sum of One Thousand (\$1,000.00) Dollars.

I also devise and bequeath to my grandson, Frederick Richmond Cottrell, the old Richmond home place, located on First Avenue in the City of Prestonsburg, Floyd County, Kentucky, and described as follows:

"BEGINNING at the Northwest corner of the ten foot (10') lot deeded by Mary R. Richmond to Inez C. Hobson and Joe Hobson on Main Street; thence running back in a Northwest direction, a distance of approximately one hundred and forty-eight (148') feet at the back end of said ten foot strip just above mentioned; thence with same to the old T. J. Ford property; thence back a Southwest course with the Ford lot to Main Street; thence up Main Street to the Inez C. Hobson's ten foot lot, the place of beginning."

ITEM 5. I will and bequeath to my granddaughter, Lida Margaret Bingham, the sum of One Thousand (\$1,000.00) Dollars, my small diamond ring, my pearl beads and my wrist watch. I also give to my granddaughter, Lida Margaret Bingham, eight (8) shares of stock in the Bank Josephine, Prestonsburg, Kentucky.

ITEM 6. I will and bequeath to my grandson, Billy Cottrell, the sum of One Thousand (\$1,000.00) Dollars, and eight (8) shares of stock in the Bank Josephine, Prestonsburg, Kentucky.

ITEM 7. I will and bequeath to my daughter, Inez C. Hobson, the remainder of my stock in the Bank Josephine, to-wit: Thirty-two and one-half (32 1/2) shares; two large diamond rings and all my jewelry except that devised to my granddaughter, Lida Margaret Bingham, and I request that my daughter, Inez C. Hobson, give to Lida Margaret Bingham, by her last will and testament, one large diamond ring.

ITEM 8. All of the inheritance taxes assessed against my estate shall be paid out of the money that I have in the Bank Josephine or other banking institution at the time of my death, and after the payment of such inheritance tax, if there be not sufficient funds to pay the three pecuniary bequests of one thousand dollars each to my three grandchildren, then, in that event said money in said bank shall be divided equally between said three grandchildren, it being my express purpose and intention not to require any of my real estate or other personal property sold to pay any of such bequests.

ITEM 9. I will, devise and bequeath to my daughter, Inez C. Hobson, all the stock that I own in the Krober Grocery & Baking Company; one-half (½) of all the Government bonds that I may own at the time of my death, the remainder of such bonds I will and bequeath to my three grandchildren; Frederick R. Cottrell, Billy Cottrell and Lida Margaret Bingham.

ITEM 10. I will, devise and bequeath to my grandson Frederick R. Cottrell, any and all automobiles which I may own at the time of my death.

ITEM 11. I will, devise and bequeath Lots Nos. 1 and 2 in the Harrison-Richmond Addition to Prestonsburg, fronting on Second Street a total distance of 120 feet and running back 150 feet to the 50-foot street and bounded on the North by what is known as Upper Cross Street of the old town of Prestonsburg and on the South by the lot occupied by C. E. Friend, being two lots making a square of land 120 by 150 feet, and being a part of the same land conveyed to me by Mary R. Richmond, by deed bearing date, August 6, 1936, and recorded in Deed Book No. 105, Page 396, Floyd County Court Clerk's Office, as follows:

One-fourth to my daughter, Inez C. Hobson; one-fourth to my granddaughter, Lida Margaret Bingham; one-fourth to my grandson, William Wilson Cottrell; one-fourth to my grandson, Frederick R. Cottrell.

ITEM 12. I also devise, will and bequeath all of the coal, oil and gas, and all mineral products and substances underlying any land which I may own at the time of my death, including both leased and unleased minerals in the following proportions:

One-fourth to my daughter, Inez C. Hobson; One-fourth to my granddaughter, Lida Margaret Bingham; one-fourth to my grandson, William Wilson Cottrell; one-fourth to my grandson, Frederick R. Cottrell. I request that said coal, oil and gas and mineral products be not sold unless absolutely necessary.

ITEM 13. I devise and bequeath to my grandson, Frederick Richmond Cottrell, eight (8) shares of stock in the Bank Josephine, Prestonsburg, Kentucky.

ITEM 14. I will, give and devise to my daughter, Inez C. Hobson, the brick house and lot located on the West side of Second Avenue, Prestonsburg, Kentucky, and now occupied by my grandson, Frederick R. Cottrell.

ITEM 15. I will, give and devise to my grandchildren, Lida Margaret Bingham and William Wilson Cottrell, the brick house and lot located on the West side of Second Avenue, Prestonsburg, Kentucky, now occupied by Fred Wesce, adjacent to and above the brick house and lot now occupied by my grandson, Frederick Richmond Cottrell.

ITEM 16. All the residue and balance of my estate, both real and personal, not disposed of by this will, I devise and bequeath as follows:

One-half to my daughter, Inez C. Hobson;
One-fourth to my granddaughter, Lida Margaret Bingham;
One-fourth to my grandson, William Wilson Cottrell.

ITEM 17. If any person receiving any benefit under this will shall directly or indirectly resist the probate of said will or seek in any way to contest said will or vacate or annul any of its provisions, then, in that event, the person so doing or for whom anyone authorized by law to act shall do so, shall forfeit all interest in any estate under this will, and my estate shall be distributed under this will as though such person had died before me, leaving no issue surviving him or her.

CODICIL

TO

LAST WILL AND TESTAMENT OF

LIDA RICHMOND COTTRELL

I, LIDA RICHMOND COTTRELL, of Prestonsburg, Floyd County, Kentucky, do hereby make, publish and declare this codicil to my last will and testament, dated August 19, 1948.

I hereby revoke and annul Items Nos. 4, 5, 6, 7, 8, 9, 10, 14, 15 and 16 of said will and in lieu thereof I hereby substitute the following to be deemed and taken as if originally inserted in said will as Items Nos. 4, 5, 6, 7, 8, 9, 10, 14, 15 and 16.

ITEM 4. I devise and bequeath to my grandson, Frederick R. Cottrell, the old Richmond home, located on First Avenue in the City of Prestonsburg, Floyd County, Kentucky, and described as follows:

"BEGINNING at the Northwest corner of the ten foot (10') lot deeded by Mary R. Richmond to Inez C. Hobson and Joe Hobson, on Main Street; thence running back in a Northwest direction, a distance of approximately one hundred forty-eight (148') feet at the back end of said ten foot strip just above mentioned; thence with same to the old T. J. Ford property; thence back a South-west course with the Ford lot to Main Street; thence up Main Street to the Inez C. Hobson's ten foot lot, the place of beginning."

I also devise to my grandson, Frederick R. Cottrell, twenty-four (24) shares of stock in The Bank Josephine, Prestonsburg, Kentucky.

ITEM 5. I devise and bequeath to my granddaughter, Lyda Margaret Bingham, my small diamond ring, my pearl beads, my diamond wrist watch and twenty-four (24) shares of stock in The Bank Josephine, Prestonsburg, Kentucky.

I devise and bequeath to my great granddaughter, Anna Margaret Bingham, my yellow gold wrist watch given to me by my son, Dr. J. T. Cottrell.

ITEM 6. I give, devise and bequeath to my grandson, William Wilson Cottrell, twenty-four (24) shares of stock in The Bank Josephine, Prestonsburg, Kentucky.

ITEM 7. I give, devise and bequeath to my daughter, Inez C. Hobson, the remainder of my stock in The Bank Josephine, Prestonsburg, Kentucky, to-wit: One Hundred One and one-half (101½) shares; two large diamond rings and all my jewelry except that devised to my granddaughter, Lyda Margaret Bingham, and to my great granddaughter, Anna Margaret Bingham; and I request that my daughter, Inez C. Hobson, give to Lyda Margaret Bingham, by her last will and testament, one large diamond ring.

ITEM 8. All of the inheritance taxes assessed against my estate shall be paid out of the money that I have on deposit in The Bank Josephine or other banking institutions at the time of my death and if I do not have sufficient money on hand to pay said inheritance taxes I direct my executor to sell a sufficient amount of Government bonds which I may own at the time of my death to satisfy the amount of such inheritance taxes, and if the cash on hand and bonds are not sufficient for that purpose, my executor is directed to collect any notes due me and apply same on said inheritance taxes, and if this amount is insufficient for the payment of inheritance taxes, then, in that event, I direct

that a sufficient amount of real estate herein devised by Item No. 16 of this codicil, or a sufficient amount thereof, be sold to satisfy said inheritance taxes.

ITEM 9. I will, devise and bequeath to my daughter, Inez C. Hobson, all the stock of the Kroger Grocery and Baking Company which I now own, or may own, or have the right to dispose of, at the time of my death.

I also will and bequeath to my daughter, Inez C. Hobson, one-half (½) of the Government bonds that I now own, or may own, or have the right to dispose of, at the time of my death.

I will and bequeath the balance of such Government bonds to my three grandchildren, Frederick R. Cottrell, William Wilson Cottrell and Lyda Margaret Bingham, share and share alike.

ITEM 10. Since the execution of my original will I have purchased a 1949 Windsor Chrysler Automobile. I now devise and bequeath to my grandson, Frederick R. Cottrell, said automobile, as well as any and all other automobiles which I may own at the time of my death.

ITEM 11. I will, devise and bequeath to my daughter, Inez C. Hobson, the brick house and lot located on the west side of Second Avenue, Prestonsburg, Kentucky, now occupied by my grandson, Frederick R. Cottrell, but subject to this condition:

There is a driveway between said brick house and the frame house now occupied by Willie Mellon, and I now direct that said driveway be maintained for the joint use and convenience of the party or parties owning said brick house, herein referred to, and said frame house, said driveway being a common easement for the benefit of the owners of both houses.

ITEM 15. I will, give and devise to my grandchildren, Lyda Margaret Bingham and William Wilson Cottrell, the brick house and lot located on the west side of Second Avenue, Prestonsburg, Kentucky, now occupied by C. M. Bower, adjacent to and above the brick house and lot now occupied by my grandson, Frederick R. Cottrell; and I also will, devise and bequeath to my grandchildren, Lyda Margaret Bingham and William Wilson Cottrell, the frame house and lot located on the west side of Second Avenue, Prestonsburg, Kentucky, now occupied by Willie Mellon adjacent to and below the brick house and lot now occupied by my grandson, Frederick R. Cottrell, but the devise of each of these houses and lots is subject to the following conditions:

It is understood that there is a driveway, in the width now established, between the said brick house now occupied by Frederick R. Cottrell and said rent house now occupied by Willie Mellon, and that there is also a drive way, in the width as now established, between the brick houses now occupied by C. M. Bower and Frederick R. Cottrell, respectively, and I direct that each of said driveways be kept open at all times and maintained for the joint use and convenience of the parties owning the properties herein named, and said driveways are to be kept open as a common easement for the benefit of each of said properties.

ITEM 16. I will, devise and bequeath to my daughter, Inez C. Hobson, all my right, title and interest in and to that certain lot located in the City of Prestonsburg, Floyd County, Kentucky, and bounded and described as follows:

"Beginning at the line of H. H. Fitzpatrick heirs; thence running up second street South 32 East 74 feet to the line of Mary D. Allen; thence South 58 West 181 feet to the line of the I. Richmond heirs, as established by this deed; thence North 32 West 74 feet to the line of the W. S. Harkins, Sr., heirs; thence North 58 East 181 feet to the place of beginning."

This being a vacant lot 74 feet wide by 181 feet deep and is a part of the same land conveyed by the Isaac Richmond Company to Isaac Richmond by deed bearing date February 20, 1920, which is duly recorded in Deed Book 55, Page 419, Floyd County Court Clerk's Office.

All the residue and balance of my estate, both real and personal, not disposed of by this will, I devise and bequeath as follows:

One-half (½) to my daughter, Inez C. Hobson;
One-fourth (¼) to my granddaughter, Lyda Margaret Bingham; and
One-fourth (¼) to my grandson, William Wilson Cottrell.

ITEM 16-A. I make, nominate and appoint Joe Hobson to be the executor of my last will and testament, and request that no bond be required of him as such executor, and that no inventory of my estate be made or taken.

In all other respects, I hereby confirm and ratify my said will dated August 19, 1948.

This codicil takes the place of the codicil dated August 17, 1950, and which codicil is now superseded by this codicil.

I hereby revoke and annul Item No. 13 of said original will dated August 19, 1948.

ITEM 9. I will, devise and bequeath to my daughter, Inez C. Hobson, all of the stock of the Kroger Company which I now own, or may own, or have the right to dispose of, at the time of my death.

I also will and bequeath to my daughter, Inez C. Hobson, one-half (½) of all Government bonds that I now own, or may own, or have the right to dispose of, at the time of my death.

I will and bequeath the balance of such Government bonds to my three grandchildren, Frederick R. Cottrell, William Wilson Cottrell and Lyda Margaret Bingham, share and share alike.

But, this devise of such bonds to my said daughter and to my said grandchildren are subject to the conditions set out in Item 8 of said will and codicil.
