LAST WILL AND TESTAMENT OF

I, Lula Davidson Trautman, a resident of the Methodist Training Camp, Newton Hamilton, Mifflin County, Pennsylvania, being of sound mind, memory and understanding and intending to dispose of all my estate and property, do make, publish and declare the following to be my last will and testament, hereby revoking all wills by me at any time heretofore made.

ITEM I. I order and direct all my just debts and funeral expenses be paid by me Executors hereinafter named as soon as conveniently may be after my decease.

ITEM II. I give and bequeath all my estate, real, personal and mixed whosoever the same may be situated to my beloved husband, Rev. Howard Monro Trautman, for life.

ITEM III. If during the life of my beloved husband, Rev. Howard Monro Trautman, he and my heirs hereinafter spoken of in this article should desire to sell and dispose of my personal property, I order and direct my Executors to distribute and pay the net proceeds of the sale of same as follows:-

One-half thereof to my said beloved husband, Howard Monro Trautman, and the remaining one-half to be paid equally to my brother, Andrew Jackson Davidson, and my sister, Martha Davidson Carpenter.

ITEM IV. Upon the death of my beloved husband, Rev.
