And the part set apart for May Allen, our daughter, bounded and described as follows: Beginning at the rock marked X, where Norman's line began going a North course with Norman Allen's line and around with the same line to the center of the Mink Branch above the house at the mulberry tree; thence up the branch with the center with Norman Allen's line to where I call the three forks of the branch where a marked rock with an X; thence up the small drain with Norman's line at west course to the top of the ridge between Raccoon and the Mink Branch when Norman's line is located; thence down the ridge between Raccoon and the branch where we live along the center of the ridge with Joel Martin's to Green Turner's line; thence down the ridge with said line to Rebecca Turner Martin's line; thence down the hill with said line to a V shaped place in a rock where once stood a cherry tree only a part of the old stump is to be seen now; thence crossing Salt Lick at Tom Turner's line with a straight line to sycamore and buckeye tree standing together on the south bank of Salt Lick; thence up the hill with said line to the top of the point/line thence down the hill to the center of a small drain and down with the center of same crossing Salt Lick with same to the beginning at the county road and we further stipulate in this Will that Norman Allen and Mae Allen.

Now for the love and respect for Warnie Conley who came to us and has been with and worked for us since he has been ten years old.

We set apart, devise and bequeath him the following boundary of land beginning in the center of the branch known as the Left Fork of Cool Water at Kaudie Turner Martin's line; thence up the branch with the center of same, which is the main branch to the head of same; thence up the hill with a straight line to a knob at the head of the Cora Gearhardt branch and the Lizzie Webb branch; thence around the head of the Lizzie Webb branch with the center of ridge to the knob at the head of the Brice Howard Branch; thence to Rebecca Turner Martin line; thence down the point with said line to Kaudie Turner Martin line at the Indian Grave Gap; thence down the hill with said line a northeast course to the beginning.

It is understood that Norman Allen, May Allen, our children shall be equal or they are to share equal in the timber and oil and gas in and on this tract should Warnie desire to sell this tract of land it is understood that Warnie is to give Norman and May Allen the first refusal to buy the same.

The east side of said branch is here in set apart granted and bequeathed to Norman Allen and May Allen our children, beginning in the center of the branch with Warnie Conley's line at Kaudie Turner Martin's line then up said branch with Warnie Conley's line to the knob at the head of Cora Gearhardt's and Lizzie Webb's branches; thence down the ridge with a east course along the center of ridge to a high knob at T. J. Turner's line; thence west with T. J. Turner's line to the beginning.

It is understood by all parties this Will is not in effect until both of the testators' deaths, when one of the testators die the title of this land reverts or falls to the one living their lifetime only. This is our last Will and Testament.
