WILL

I, MOLLY LAYNE, of Betsy Layne, Floyd County, Kentucky, being of full age and of sound mind and memory, do make, publish and declare this to be my last will and testament, hereby revoking all wills by me heretofore made.

ITEM I. I hereby authorize and direct my Executor hereinafter named to pay all my just debts and funeral expenses as soon after my death as they can conveniently do so.

ITEM II. I give, bequeath and devise to my beloved daughter, Emma Lou Layne Robinson, who has so patiently cared for me during my illness, the following described property:

The property known as the "Storehouse Property", which begins at the street in front of said storehouse and running with the line of the property now owned by Emma Lou Layne Robinson at the lower side of said storehouse, and with her line to the line of Richard Layne; thence with the line of Richard Layne to the far corner of the barn now located on said lot and so as to include said barn; thence a straight line to the river to the line of the alley adjacent to Ares. Gearhardt's property; thence with the line of the alley back to the street; thence with the street to the beginning, so as to include all the land in said boundary including the store building and all equipment in said store building and barn located

on said property. The garage on said property is to go to my daughter, Madge Layne Cyphers, and she is to remove it as soon as practicable after my death.

I further desire that the income or rents, from the store building and equipment therein be given to my husband, Tom Layne, as long as he remains my widower, and should he cease to be my widower, the full rights to said building are to go to my daughter, Emma Lou Layne Robinson.

I further desire that he shall pay the taxes on this property so long as he received the income therefrom.

ITEM III. I give, bequeath and devise unto my beloved son, Richard Layne, a one-half interest in the following described property;

All of the remainder of my real estate from the barn as set out in Item II, back as far as it runs.

And I desire that he shall have the lower 1/2 of said property which is adjacent or bounds part way on property already owned by him.

I further desire that my son, Richard Layne, is to have the chicken-house which is now located near the barn.

ITEM IV. I give, bequeath and devise to my beloved daughter, Madge Layne Cyphers, the other, or upper, half of the property mentioned above in Item III, which is half of the remainder of the property directly back of the barn, and being the part adjacent to the property of Mrs. Gearheart.
