I, W. S. CLARKE, of Dewey, Kentucky, being of sound mind and disposing memory, do hereby make, publish and declare this last will and Testament, hereby revoking all former wills made by me.

ITEM I I desire that all my just debts, doctors bills, hospital bills and funeral expenses be paid out of my estate.

ITEM IV. ITEM V. I charge my son L. W.
