

ITEM I. I hereby direct the executor of this will, hereinafter named, to provide for and pay out of any money or personal property owned by me at the time of my death, all of my just debts and funeral expenses.

ITEM II. All the property, real, personal and mixed, subject to the further bequest and limitations hereinafter mentioned, which I may own or have the right to dispose of at the time of my decease, I give, bequeath and devise to my only son, Joe May, Sr. If Joe May, Sr., dies before I do, then, I direct that the property bequeathed by this will shall go to his wife, Elizabeth P. In the event my said wife should prior to the time of her death, become mentally or physically incapable of managing or operating said farm, then, I direct that my said trustee, aforesaid, may as such, take over and administer the said affairs of said estate out of the income of which he is to provide, for the support, maintenance, and well being of my said wife, during her lifetime and to provide for her burial expenses.

JOINT WILL OF PAUL AND ZONA WALLER

We, PAUL WALLER and ZONA WALLER, of Prestonsburg, Floyd County, Kentucky, make, publish and declare, each in consideration of the execution thereof by the order, this as our last Will, hereby revoking all wills and other testamentary dispositions of property heretofore made by us.

ITEM I. We direct that all of our just debts and funeral expenses be paid out of our estate as soon as practicable after the time of our decease.

ITEM II. We have made gifts and advancements, from time to time, to our children, Edith Waller Blair, Gertrude Waller Broy, Paul Raymond Waller, J. B. Waller and Maggie Belle Waller Fendergrass, and we may hereafter make further gifts and advancements to them. For this reason, we are limiting the bequests to the above children under this will to the sum of One Dollar (\$1.00) each.

ITEM III. All of the rest and residue of our property which we have the power to give or bequeath at the time of our deaths, whether real or personal, of every kind and description, wheresoever situate, to the survivor, for his or her lifetime, and upon his or her death, then such property shall go to and the title thereto shall be vested in our two children, Anna Marie Waller and Danny Lee Waller in fee simple. FIRST: I direct that all my just debts and expenses of my last illness and burial be paid as soon as practicable after my decease.

SECOND: I give and bequeath to my two daughters Ava Lee S. Allen and Eula Mae Salyers to be as follows.

TO AVA LEE S. ALLEN: Beginning at culvert in branch on and Henry Edward Allen her husband; highway near barn running with the branch up the branch to the upper end of the old garden which is about 800 ft. from the highway where the road crosses the branch. Ava Lee S. Allen is to give a road 10 ft. wide from the branch up to the edge of timber. This road is for both sides of the branch land owners to use.

Then beginning at the edge of timber, Ava Lee S. Allen line follows the branch to the foot of the hill, then a straight line to the top of hill turning left following ridge to Steve Richardson's line then down the hill to highway following highway down to the beginning at culvert.

TO EULA MAE SALYERS: Beginning at highway at Oscar Richardson's line running with this line that is between Oscar Richardson and Sula R. Salyers to the top of the hill where it joins Bill Adam's line. Then turn left on top of the ridge to where Ava Lee S. Allen line gives a straight line down the hill to meet the head of the branch then following the branch down to highway, then down the highway to the beginning.

Ava Lee S. Allen is to use a 10 ft. road over Eula Mae Salyers from upper end of the old garden running down the branch through barn lot to the highway. This road meets the 10 ft. road on the left side of branch which is on Ava Lee S. Allen land.

THE MILL PIECE is to be equally divided running from the highway to the creek. Between Ava Lee and Eula Mae only.

THE GAS LINE that is attached to the 6 inch line is to serve the purpose of both homes and the gas bills is to be paid as seen fit.
