

ITEM II.

I made a gift to my daughter, Emma Marshall, consisting of a tract of land located on the Hutton Fork of Bull Creek in Floyd County, Kentucky, of the value of Five Hundred (\$500.00) Dollars, and I direct that the conveyance for said tract of land by me to her be considered as an advancement, and shall, by my executors, be charged against her, and she shall receive nothing from my estate until each of my other children have received from my estate the sum of Five Hundred (\$500.00) Dollars each.

ITEM III.

I made a similar gift to my daughter, Ruth Meade which she was required to sell because of her husband's sickness and physical condition, and for that reason I direct that said gift shall not, in any manner, be deemed as an advancement to the said Ruth Meade, or be counted, in any manner, in the settlement of my estate.

ITEM IV.

Subject to the provisions of Item II, I devise, give and bequeath all the property, both, real, personal and mixed, of every kind, whosoever situated, which I may own or have the right to dispose of, to my seven children: Julia Cooley, Emma Marshall, Mae Laddy, Ruth Meade, Otis Cooley, W. R. Cooley and Orville Cooley, but the advancement, mentioned in Item II, shall be deducted from the part of my estate devised to my daughter, Emma Marshall.

ITEM V.

I make, appoint and nominate my two sons, Otis Cooley and Orville Cooley my joint executors of this, my last will and testament, and in the event one of my two sons dies before I do, the survivor shall exercise the powers of said office, but if they each survive me both of them shall jointly serve as the executors of my estate.

I further request that no bond be required of said executors, or either of them, and that no inventory of my estate be made.

" LAST WILL AND TESTAMENT OF FRANK P. HALL "

In the name of God, Amen;

I, Frank P. Hall, of Weeksbury, Floyd County, Kentucky, considering the uncertainty of this mortal life, and being of sound and disposing mind and memory, blessed be God for the same, do make and publish this my last will and testament, in the manner and form as follows, that is to say:

FIRST: I direct that my burial expense, and all my debts, if any there be justly proven, be paid out of my personal cash/account at the First National Bank, Pikeville, Kentucky, and a like amount be reserved in said bank to pay the funeral expense of my beloved wife.

SECOND: I direct that a double granite stone not over three feet high above the base, of moderate cost, to mark the final resting place of my wife and myself, same to be purchased from Brother Bennett Adams, and to be erected as soon as possible after my demise.

THIRD: I give and bequeath to my beloved wife, Frankie Hall, all my money; all my personal property, my law library; all live stock; all household furniture and all bonds. Also, all my real property, home farms and lands wherever located. (Out of this property my wife shall take care, as she sees fit, of our daughter, Ora Fay)

FOURTH: There is this notation to be observed. My daughter Ola Mae, and her husband, Atha Dameron, are operating my store and for their services are to receive as compensation 75% of all profits earned through said store, and the remaining 25% is hereby given to my wife. (The banking account in the name of Frank P. Hall Store and the inventories shall govern the Store business relative to the sums each have in the store).

FIFTH: I appoint my beloved wife, Frankie Hall, Executrix, of this my last will and testament, hereby revoking all former wills by me made, and direct that no inventory to be made of any of my property, except the store, and that my wife serve as such executrix without bond.

SIXTH: If my beloved wife does not consume all my property above mentioned during her lifetime, the residue thereof, I direct be equally divided among my children, share and share alike, quality and quantity to be a factor to be considered in said distribution. The Distribution shall be made by three citizens agreed upon by the children and their distribution shall be final. But if any child objects to its share of distribution set apart by the said three citizens and shall go to court as a result thereof, the said objecting child shall be excluded from inheriting herein and the property shall go and be distributed among the other children.
