(h) In the event of the death of the said Jonathan Holbrook prior to the termination of the trust hereinbefore created, then the remainder of my children then living, or the majority of my said children then living, may be instrument of writing duly executed, acknowledged and recorded in the office of the Clerk of the Floyd County Court of the State of Kentucky, designate a Trustee to act in the place and stead of the said Jonathan P. Holbrook; and likewise and from time to time, by similar instruments or writing any vacancy in the office of such Trustee may be filled by the remainder of my children then living, or the majority of them.

SIXTH: I do hereby nominate and designate Minerva H. Spradlin as Executor of this, my last Will and Testament.

ITEM 1: I hereby wholly revoke any and all prior wills heretofore made by me.

ITEM 2: I direct that all my funeral expenses and just debts and obligations be paid.

ITEM 3: I devise to my sister, Cynthia Hatfield, absolutely and in fee simple the tract of land lying on Bull Creek containing about 25 acres, part of which I inherited and part of which I purchased, known as the Lower Farm or Bill Music farm lying near the school house.

ITEM 4: I bequeath to my sister, Cynthia Hatfield, all the money and personal property that I may have on hand at the time of my death but I desire that she pay out of this money my funeral expenses and such debts that I may justly owe.

ITEM 7: I appoint my sister, Cynthia Hatfield, to be the executrix of this my last will and testament and direct that no bond be required of her and that she be excused from and not required to make or file any inventory or settlement with any court or officer.
