1ST. I will and bequeath unto my three boys, Harrison (Bird) Johnson, Frank Johnson and Charley Johnson all of the tract or boundry of land that I now own and reside in on the waters of the Caney Fork of Middle Creek or any other lands that I may die the owner of.

2nd. I will and desire that my three sons above named pay out of my personal estate to the heirs of my daughters Leroy the sum of \$5.00; to my daughter Levisa the sum of \$5.00; to my daughter Dove \$5.00; to Clarendia \$5.00; to my daughter Beil \$5.00; to my daughter Sarah \$5.00 and my daughter Alice the sum of \$5.00 each.

3RDs: It is my will that all of the household and kitchen furniture be equally divided among my daughters herein before named.

4THs: It is my will that should my wife be living at my death that my wife Anna Johnson have the use and full controll of my lands and everything that of a personal character for and during her life time and after her death to be carried into effect as set forth in items 1, 2, and 3, of this instrument.

5THs: That after my decease that my body be decently burried and same to be paid out of my personal estate.

THs: I hereby appoint William Dingus my Executor to see that the provisions of this my last will be carried out as herein before named.

I, Alice G. Hopkins (widow of the late Frank A. Hopkins) of the City of Prestonsburg, County of Floyd and State of Kentucky, being of sound mind, and disposing memory but realizing the uncertainty of life, do make publish and declare this to be my last will and Testament, hereby, revoking any other and all Wills heretofore made by me.

1st. I direct that all my just debts and funeral expenses be paid out of my estate as soon as possible after my decease.

2nd. I have made advancements to each of my three children Elizabeth A. Layne (wife of Will H. Layne) John C. Hopkins and Josephine D. Dimick (wife of Thomas E. Dimick) all of which advancements whether now, or hereafter made will be shown by checks written to their order on the Bank Josephine of Prestonsburg, Kentucky having the words loan or advancement written on the checks - same will be found among my paid cancelled checks and are to be charged against my said three children Elizabeth A. Layne, John C. Hopkins, and Josephine D. Dimick, no interest shall be charged on any such advancements.

3rd. Having heretofore given my Grand Daughter Elizabeth Grayce Burke wife of (A. B. Burke) a Grand Piano for which I paid the sum of \$500.00 (Five Hundred Dollars) that has been taken into consideration and charged against her, in making bequests to the Layne Children, I further will and bequest unto my said Grand daughter Elizabeth Grace Burke my Shriner's Pin, Steamer Trunk and one of my Diamond Ear Rings to her daughter Alice Gray Burke who is named for me to be kept and taken, care of by Elizabeth Grayce Burke, until her daughter, Alice Gray Burke is eighteen years old, at which said time the Ear ring is to be given to my Great Grand Daughter Alice Gray Burke.

4th. In September 1924, I paid the Greenbrier Military School of Lewisburg, West Va., the sum of \$475.00 (Four Hundred and Seventy Five) dollars for tuition for my grandson Frank H. Layne, and also gave him the sum of \$25.00 (Twenty Five Dollars) to pay his expenses going there making a total of \$500.00 (Five Hundred Dollars) have given him already, I further will and bequest unto my Grandson Frank H. Layne his Grand Father's Gold Watch and Chain, which he's been using for several years.

5th. In September 1924, I paid the sum of \$275.00 (Two Hundred Seventy Five Dollars) for my Grand Daughter Alice Angeline Layne, to pay her tuition to the Greenbrier College for women at Lewisburg, West Va., I further will and bequest to my Grand daughter Alice Angeline Layne the sum of \$225.00 (Two Hundred Twenty Five Dollars) to make a total of \$500.00 (Five Hundred Dollars) the same amount as that given to my Grand Daughter Elizabeth Grace Burke and Frank H. Layne, If the said \$225.00 (Two Hundred and Twenty Five Dollars) is paid by me to Alice Angeline Layne or her account, before my decease, that I cancel this bequest, as this amount will make the same given to each child in the Layne family equal \$500.00 (Five Hundred Dollars) thus amounting to \$1,500.00 (One Thousand Five Hundred Dollars) to the three Layne Children, Elizabeth Grayce Burke, Frank H. Layne and Alice Angeline Layne. I further will and bequest unto my Granddaughter Alice Angeline Layne, my Gold Watch with small diamond in the center on one side, and my Monogram A. G. H. on the other side. I further will and bequest unto her my wardrobe Trunk.

6th. I will and bequest unto my Granddaughter Alice Hopkins Dimick the sum of \$1,000.00 (One Thousand Dollars) which amount added to the cost of a Piano bought for her will equal the amounts paid for, and given to my three Grand Children in the Layne family. I also will and bequest unto my Granddaughter Alice Hopkins Dimick who was named for me my Diamond Brooch, but her mother is to keep same for her until she is twenty one years of age, and in the event of her death, the Brooch is to be given to her mother Josephine D. Dimick.

7th. I will and bequest to my Grand Son John Calvin Hopkins Jr., the sum of \$1,200.00 (Twelve Hundred dollars) to be paid to his father John C. Hopkins for the use and benefit of the said John Calvin Hopkins Jr., which amount added to the Piano I gave him, will be equal to my three Grand Children in the Layne family.

8th. Unto my Son John C. Hopkins I will and bequest the following named articles to wit: His Father's complete Knight Templar's out fit; walnut Bed Room Suit, and Wardrobe used in his room; longest Mahogany Table; His Father's large leather chair, Large Picture Washington at Valley Forge; Picture University at Charlottesville Va., Small Gilt Clock and Old Fashioned Wooden Clock with Calendar; His Father's Knight Templar's Chain, and his Father's Diamond Stick Pin. The Diamond Stick Pin to be kept by his father John C. Hopkins until John Calvin Hopkins Jr., becomes twenty one years of age, at which time the said Pin is to be given to the said John Calvin Hopkins Jr.,

9th. I will and bequest unto my daughter Josephine D. Dimick, one of my Diamond Ear Rings, wrist Watch which she gave me, Marble top Center Table, and the middle sized Mahogany Table with the large round legs - Large Crystal Clock, writing desk and Chair to it, walnut set of Furniture bought from the Judy's by Leather Rocking Chair, and Silver Toilet Set with A. G. H. on it, The two small Gilt paintings called Spring and Summer, My entire set of Limoges Dishes.

10th. I will and bequest unto my Daughter in Law Valentine my Latoka Pearl Necklace, and my Ivory Toilet Set.

11th. In the second paragraph hereof - I have referred to certain advancements made to my three Children Elizabeth A. Layne, John C. Hopkins, and Josephine D. Dimick (wife of Thomas E. Dimick) by me from time to time. Now in order to equalize said advancements I direct that the said advancements, so made by me to my daughter Elizabeth A. Layne, shall be charged against the said Elizabeth Grayce Burke, my daughter Hopkins Layne, and Alice Angeline Layne in the distribution and division of my said property and estate.

12th. After the payment of my just debts, and funeral expenses, as provided in clause 1st on sheet No. 1 - of this will, I will, bequest and devise to my two Children, John C. Hopkins and Josephine D. Dimick (wife of Thomas E. Dimick), to be equally divided between them the following property to wit, whatever cash I may have on deposit in the Bank Josephine at my decease, Liberty Bonds, my Life Insurance, which is share payable to my estate, amounting to almost Four Thousand Dollars, and Twenty Nine Shares of Stock in the Bank Josephine.

I further will, bequest and devise the remainder of my property and estate to my two children John C. Hopkins and Josephine D. Dimick (wife of Thomas E. Dimick) and to my three Grand children, Elizabeth Grayce Burke, Frank Hopkins Layne and Alice Angeline Layne, Children of my deceased daughter Elizabeth A. Layne in the following proportions and upon the following conditions. To my Son John C. Hopkins, I will, bequest and devise the equal one third. To my Daughter Josephine D. Dimick (wife of Thomas E. Dimick) I will, bequest and devise the equal one third. To my three grand children, Elizabeth Grayce Burke - Frank Hopkins Layne, and Alice Angeline Layne I will, bequest and devise the equal one third, Interest to be subject to deduction of the loans, or advancements made to the respective parties, as set forth in clause 2nd, Sheet 1st, and clause 11 sheet 4 # of this will.

13th. I hereby nominate my two Children John C. Hopkins and Josephine D. Dimick (wife of Thomas E. Dimick) Executors of this my last will and Testament, and request that no bond be required of them, or either of them, and direct that they shall settle my said Estate as soon as is possible after my decease, I further set there shall be no inventory, or public appraisal of my Estate be made.
