LAST WILL AND TESTAMENT

I, LEONA B. HALL OAKS, of Prestonsburg, Kentucky, being of full age and of sound mind and memory, do make, publish and declare this to be my last will and testament, hereby revoking all wills by me heretofore made:

ITEM 1: I direct that all my just debts and funeral expenses be paid from the proceeds of my life insurance policy in which my sons, Norman H. Hall and Charles L. Hall, are beneficiaries.
