

I give my negro boy named John and the gray geld and one feather bed and bedding - and to my daughter, Eliza I give my negro boy named Sam and also fifty Dollars in specie to be paid her when she shall arrive to the age of sixteen out of the money arising from the sale of the estate the balance of my estate to be sold and the bonds which I hold for money due my if ever collected to be equally divided among my five children namely Job, George, Jacob, Jane & Eliza D. and lastly I do appoint my son Job Sharp and Edward Wall my Executors to this my last will and testament hereby revoking all others In witness whereof I have hereunto set my hand and seal this 23<sup>rd</sup> day of October in the year of our Lord one thousand eight hundred and twenty three

In the name of God amen I William Sneed of the County of Franklin in State of Kentucky being weak in body but of sound mind and perfect memory do make this my last will and testament in the manner following to wit, That all my just debts and burial expenses be first paid and then satisfied It is next my wish and desire that my negro man Reuben and my Negro woman Colia be free from after my death and that Colia have one hundred dollars paid to her by my Executors out of my estate I Give to my brother, Sandon Sneed the following Negroes to wit, Collick, William, Henry Jack and Sally, to him and his heirs forever, I Give unto the heirs of my brother, Achilles Sneed the balance of my Negroes, to be equally divided between them I give to my brother, John Sneed the plantation whereon I live together with my stock of Horses cattle sheep, Hogs Household and kitchen furniture and farming utensils I next appoint my brother Sandon Sneed and my friend James Millam Executors of this my last will and testament hereby revoking all other wills by me heretofore made In My testimony whereof I have hereunto set my hand and seal this second day of August 1827
