of the County of Lincoln and Shire of Kent
Being in perfect health of Body and of Perfect mind
and Memory thanks be given unto god calling
unto mind the mortality of my Body and know-
ing that it is appointed for all men once to
die make and ordain this my last Will and
Testament that is to say Principally and first
of all I give and Command my Soul unto the
hands of Almighty god that gives it and my
Body I recommend to the Earth to be buried
in decent Christian Burial at the Discret-
ion of My Executors Doubtless at the general
Resurrection I shall survive the same again
by the mighty Saviour of god and as touching such
Worldly Estate wherewith it hath pleased god
to Bless me in this life, I give Dismiss and
dispose of the same in the following manner
and form, first I give and Bequeath to yeane
my Dearly beloved wife all my Stock of home
Cattel and hogs also all my household and
Kitchin furniture and Plantation utensils

With all my Estate Except what is what is hereafter
Excepted to be to the proper use and Benefit of her and her
heirs forever, after paying all my just and Lawfull Debts
Also I give and Bequeath to my beloved Wife Jane an
Negro girl named Nelly to be the proper use and
Benefit of her and her heirs for ever. I also give and
Bequeath to my well beloved Sister Suskey Sops and
her heirs forever all that I shall Come to me out of
the Estate of Christopher Suttons Decease if any
there be Except what I shall be hereafter Excepted
I give and Bequeath to Rowlen Sutton Son of
John Suttons an Equal Share with one of my Sister
Suskey Children of the aforesaid Estate of Christopher
Suttons Estate if any there be. Also I appoint
My Well beloved Wife Jane Sutton and my
trusty friend Elezander Pope Executor of this my
last will and testament; Signed and acknowledge
this twelfth day of July, Seventeen hundred and
Ninety five in the presence of

of Fayette County and State of fine shillings likewise
I give unto my Son John Scotts Children which
his first wife had (viz) Samuel Scott Thomas
Brown Scott Sarah Scott Robert Scott and
William Scott. That plantation lying in York
County and State of Pennsylvania bounded by land
of William Read and Thomas Shannon to be
hold and the money to be Equally Divided amongst
of Children. like wise I order all the rest
of my Estate Real and personal in the
