 authorize them to rent or lease my estate or any
 part thereof —
 3^d The residue of all my estate of whatever kind
 after paying my debts & expenses I give and
 bequeath to my Daughter Malinda & Baby Moore
 & their heirs to be equally divided between them
 by my said Executors in such ^{manner} and at such times as
 they think proper it is also my will and desire
 that the mother of the said Girls be decently maintain

 straight line to the nearest corner of son Wm's
 orchard fence thence with my line all the way
 to the Beginning my two Slaves also Nicket and
 Dick my horse Policy and ^{his} Sorel Horse and
 saddle three beds and furniture my Chest
 and my two Bibles all of which ^{have they free} shall
 and uninterrupted use of During his life
 but it shall be at the discretion of my
 Executors
