In the name of God my beloved Creator to whom
I am indebted for a long life and the Estate which of
God's goodness I have received of the Town of Henric
and State of Kentucky being in weak health and
advanced in years but in full possession of my senses
I do hereby make and declare this my last will
and Testament in manner and form as following
to wit, I give and devise to my Daughter Mary
Shaver during her natural life to enable her to
support and maintain her son infant children
Thomas & Peter David Emily Sarah and William
I have my tract of land lying in Henderson
County now in her use and occupancy which was bought
by me of Henry Purser and conveyed by him
for himself and others to me on the 5th day of September
1811 containing two thousand acres of land this tract
of land has been improved and I believe it industriously
cultivated will yield enough to support her children
for which purpose it is a good gift and for no other
and it is my will and desire if this Court is convinced
is any otherwise than that of supporting my said infant
children I do hereby declare that the above said
land should be sold and the money arising therefrom divided amongst
the said children as follows I further give and

devise my house tract of land at the mouth of the said
Mary Shaver and after the termination of her Estate
therein to the said Thomas Peter David Emily Sarah
and William Shaver her children and my grand children
to be equally divided amongst them and my Executors
I do hereby name after named as trustees and instructed
to sell and convey the said land and to cause an equal
division of the money arising therefrom amongst them
or otherwise cause an equal division to be made as they
respectively arrived at the age of twenty and years or over
I mean until which time it will be best and it is my
will that the yearly profits of the land only be devoted
amongst them for their Education and maintenance
and when during my daughter's lifetime in Henderson
County I have from time to time sent her such things
as her family stood in need and wore Goggles Horns and
Household Furniture until then has accumulated a
considerable property in stock and household Furniture
and utensils in her possession and it is my wish that her
family aforesaid may remain in the use and benefit of the
property I give and devise to my said Daughter Mary
Shaver for the use and benefit of my said Daughter and
her son children before named all the stock & property
of every Description which shall be found on the said farm
and premises at the time of my decease to be so managed
by them with the advice and direction of her mother as far
as may concern to their maintenance and comfort and
I further will and desire that all the death of my said
daughter and the property ^{which} I give shall be sold and
the money arising therefrom devoted between the said
children before named in manner and time before specified
in regard to the land as before my hand and seal
this Seventeenth day of September in the year of our
Lord 1812
