which woman I intended to be released from had I lived, but if this woman
should have a child within nine months after my death and my Executors
think that it has any resemblance of my family they may divide with it
of my estate what they may think proper but if they deem it improper to
give it any thing, for them to give all my estate to my two sons Garret
