Davis all the estate real, personal & mixed, money, choses in action or debts due me, of which I may die possessed or the owner of, after the payment of the legacies aforesaid and all my just debts. My said debts consist of a tract of land containing eighty acres lying on the waters of Rave Creek, in Henderson County, Kentucky, on which I formerly lived, and two old negroes, one a man named Charles & the other a woman named Rozella. One bed & bedding. One shot gun, I about five hundred dollars in debts due me & some books. I give the above mentioned property & all other property, money, choses in action or debts due of which I may die owner to my said son Charles W. Davis for & during his natural life, and after his death to my grand children & Robert the children of my son Charles W. Davis & such other children as my said son Charles W. I give to my two Grand sons John Lynn Fisher and Henry Fisher the tract of land whereon W. Fisher now lives, to them and their heirs forever. My wish and desire further is, that the County Court of Henderson appoint some one to act as my administrator to this my last will and Testament. If there is money enough after all my debts are paid I want to give to Anne H. Alford 50 dollars and to each of my grand daughters 50 dollars. Elizabeth Soaper, Harriett H. Soaper, and Kate H. Soaper, to be carried out just as I have put it down.
