

Henderson Ky August 26th 1898

I Jefferson D. Fisher, of Henderson, Henderson County, Kentucky, being of sound mind and body, do hereby make this my last will and testament.

1st I have two policies of insurance on my life. One in The New York Life Insurance Company, of New York, in the sum of Seventy Five Hundred (\$7500.00) Dollars, and one in the Metropolitan Insurance Company, of New York, in the sum of Five Hundred (\$500.00) Dollars of the last named policy, I have already assigned the sum of Five Hundred and Fifty (\$550.00) Dollars to F. O. Taylor, to receive for money which he has from time to time advanced me.

2nd I desire that all of my just debts be paid from the proceeds of said two policies of insurance, after said \$550.00 has been paid to said Taylor, as above set forth, and after said debts shall have been paid, it is my will that the money then remaining be equally divided between my mother, Mrs Louisa Fisher, wife of Louis Fisher, of Henderson County, Kentucky, and my three sisters, Mrs Mattie E. Taylor, wife of F. O. Taylor, of Henderson, Henderson County, Kentucky, Mrs Mattie J. Maloney, wife of E. H. Maloney of Henderson County, Kentucky, and Miss Laura Fisher of Henderson County, Kentucky, share and share alike.

3rd I will and request to F. O. Taylor, my sister Laura's portion of said money, to be held by him in trust for her till she shall become of age.

4th I hereby appoint my brother in law, Frank O. Taylor of Henderson Ky, as administrator of my estate.
