- I John H Jacobs being at the Present time of sound mind but realizing the fact that life is uncertain do make this my last Will and Testament
- 1st I leave to my beloved wife Paulina Jacobs the whole of my Estate in trust for my Children during their Minority to raise Educate and take care of them untill they arrive at the age of Twenty one year with the following Conditions I wish my Executor hereinafter named to rent out my two Farms as may be best so as to derive the most profit and not impoverish the Funds
 - 2nd Out of the proceeds of the crop now on hand and Monies due me from ~~sales and~~ ^{the} ~~Debtors~~ I wish all of my just debts to be paid and I wish all of my Stock of every description except what my wife may wish to retain sold and after the payment of my just debts the money left and not needed by my wife for the Support of herself and Children to be securely invested or loaned out
 - 3rd I hold a Policy of Life Insurance in the New York Life Insurance Company for (\$2500) Twenty five hundred dollars which I wish securely invested or loaned out on real Estate Security the Interest to be paid Semi annually to my wife untill my youngest child arrives at the age of 21 years for the Support and Maintenance of all my Children
 - 4th If my wife should Marry then all the above and foregoing Consideration are to be set aside she agreeing to take a child's part in my Estate at the time of said Marriage or the sum of One thousand dollars in money from the residue of my Estate to go to my Children in Equal proportion
 - 5th I also wish ^{my} Nathaniel Thomas L Jacobs shall have a Support out of my Estate as long as he lives and if he should elect to live elsewhere then with my wife then a sum not to exceed One thousand dollars to be paid him yearly as long as he may live by my Executor
 - 6th I wish my wife to use economy and not to waste my Estate and she is not to use any more of the Surplus or interest than may ^{absolutely} necessary for the Support and Maintenance of my Children and to Educate them
 - 7th If my wife ^{should} live on either of my Farms she is to have as much Land as she requires for my son William to work or my other sons as they grow large enough to work or any one she may wish to employ the residue to be ~~distributed~~ ^{paid} out as heretofore mentioned
 - 8th If any difficulty should arise between my wife and my Executor about anything contained in this my last will and Testament I leave the settlement of the difficulty with the Judge of the Henderson County Court I appoint my Friend Dr J H Cropper Executor of this my last will and Testament and also Guardian of my Children
