Henderson Ky November 1875

In the name of the Father, and of the Son and of the Holy Ghost Amen, I Lawrence Dwyer of the City of Henderson, Henderson County Kentucky, being of sound mind and in good health, do make this my last Will and Testament: I bequeath to the Roman Catholic Bishop of Louisville Ky. and his successors in office my real estate namely: Lots No^s twelve (12) thirten (13), fourteen (14) fifteen (15) sixteen (16) twenty-five (25), twenty six (26) and twenty seven (27) of the town of Lawrence Evansville Indiana, recorded in Deed Book No^s 8 pages 526 & 527 in the Clerk's office at the Court House of Evansville Ind., to be used for the Roman Catholic St. Louis Church and Roman Catholic St. Louis School of the City of Henderson Ky. and all other personal, real or mixed estate I may die possessed of. In compensation for the above bequeath, I beg from the Roman Catholic St. Louis Church at Henderson Ky. an honorable funeral, and one hundred dollars to be put into the hands of the Roman Catholic Pastor of said Church, to be used for the good of my soul at his discretion. I appoint Thomas Ryan my Administrator to carry out the provisions of this my last will, and I do not desire that he shall be required to give security for the performance of his office. Third I give and bequeath to Lucina Smith wife of Thomas Smith the sum of Four hundred dollars to be used in part to be a home for said Lucina during her life and then to her daughter Caroline Smith

Fourth I give and bequeath to John D. Lundy son of my Brother Samuel D. Lundy the sum of One hundred and fifty dollars

Fifth I give and bequeath to the children of my Sister Finkert namely Sallie I Winkler Martha I Cannon & Thomas I Cannon each the sum of Four hundred dollars

Sixth I give & bequeath the balance of my estate to be equally divided among the children of my Brother Saml M. Dunning

Seventh & my estate consists chiefly of a farm or plantation of One hundred acres of land in Indian land on the Ohio River in Henderson County Ky I direct my Brother Saml M. Dunning & wife to have appoint my Executor to sell the same so to get the best price either to sell for cash or on time or after having as it

specifies herein bequeathed to all others except his own children he may hold the farm or tract of land in trust for his children after paying himself from said for the money advanced

Subscribed by my own hand this the 13th day of November 1872 and afterwards acknowledged before the subscribing Witnesses
