Merchant, Executors of this my last Will & Testament - Item I
give and bequeath unto Eleana, Eliza, Martha Patton and Eliza
Wife of Louisville aforesaid a Legacy or Sum of One hundred Pounds
a piece - And all the rest residue & remainder of my Estate both Real
& Personal whatsoever and wheresoever I give devise & bequeath in man-
ner following, that is to say, One full and equal fourth part thereof unto
my Brother James Reed of the County of Derry in the Kingdom of Ire-
land, his Heirs & Assigns - And in case my said Brother be
dead at the time of Executing this my Testament, dead or die before me
then the said fourth part into his Children to be equally divided between
them & their Heirs & Assigns, and the Sum of each of them as may be dead
