be done without involving the family.

2nd I likewise give to my second son Rezin M Garrett the sum of
eight hundred and thirty dollars to be paid in like manner.

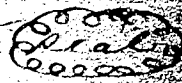
3rd I give and bequeath to my well beloved wife Judith Garrett
the plantation I now live on, containing by survey 183 acres late
purchased of Mr Benjamin Stafford, lying on the waters of Floyd
Co^{ty}, and with it all the hereditaments and appurtenances thereunto
belonging, together with all the farm hots, orchards, stock, far-
ming utensils, household and kitchen furniture, to be freely pos-
sessed and enjoyed by her during her natural life.

I likewise give to her the said Judith Garrett five negroes To wit; George
Rachel, Alley, Henry and Sam, with all their increase to be fully and
entirely possessed by her during her natural life, investing her with
authority and power to emancipate all or either of them, together with
their increase, if any, or to retain them bond slaves, whichever she
may think most expedient at her departure; if she thinks proper
to retain them in slavery they are to be disposed of as the rest of
my property hereafter named, with her.

4th All the rest of my estate both real and personal of what
nature or kind soever it may be, not herein particularly

All the rest of my Estate both real and personal of what
nature or kind soever it may be, not herein particularly
disposed of, I desire to be equally divided between my above
named wife and my three youngest children, Peter B. Susan
H. and Hilsey Ann Garrett, Except my wearing apparel, watch
and rifle gun, which I give particularly to my youngest son
Peter B. Garrett, the whole to be freely possessed and enjoyed
by them and at the death of my wife, her share of the last dis-
posed of property and estate to be equally divided between the
three above named youngest children And the interest arising
from the whole of this last disposed of property and estate, until
such time as the three youngest children come of age I give to
my wife for the purpose of raising, clothing and schooling of them
And lastly I do hereby constitute and appoint my friends George
Seaton Esqr and Wm Maxwell Executors of this my last will
and testament, hereby revoking all other or former wills or
testaments by me heretofore made.
