 is to maintain the two Girls till of Age - the Land that I bought
 of Nicholas Brashears I leave to my son Samuel Mason Brashears
 as for the rest of my Children I think what they have had all Ready
 is sufficient for their parts there fore I dont a love them any Part
 but What the law does a love - Therefore I leave all to my three
 Children as mentioned I do constitute and appoint my loving
 son Samuel Mason Brashears my lawfull Executor and
 Administrator to perform this my last Will and Testament in
 Witness Whereof I have hereunto set my hand & seal this
 26th day of September in the year of our Lord one thousand seven
 hundred & Eighty Nine. - 1789-
