under Gen. Clay's writing and instrument

he intended to be his last will if he never
returned in, he gave the whole of his property
that came by his father to his sister Mary Steele
which I did accordingly and in the same was

I do hereby certify that I
heard Mapasa Steele in possession of
my property shortly before he started on the expedition
from which he never returned that he
intended all the property on my part
to be his property of that he would make a will

this 18th day of August 1813.

The subscribers state upon oath that
some time before Mapasa Steele's departure
stated to the Commission which was under
General Clay he declared to me he intended
to give to his sister Mary Steele the whole
of his property that came to him by his
father and if he never should return that that

said Mapasa Steele state a few days before
he started to General Clay's campaign that his

brother Ephraim Steele had joined the Shakers
further he and him state that he would have
the whole of the estate left by his father to him he
would have to his sister Mary Steele only
state he had an affidavit taken before me
given under my hand this 14th day of September 1813.

you mean to do with your estate I suppose your brother
Ephraim the Shaker will enjoy it in case you never
return it in a few days he observed that he had
disposed of his brother the Shaker of that advantage
for he had made his will before he left home and
gave to his sister Mary Steele the whole of his
estate which she was possessed of and further the
said Mapasa Steele given under my hand this 15th
day of September 1813.
