I purchased of him I also give him six hundred and one acres of land in Ohio County on a branch of Green River lying on a branch of said River called Lewis Creek dead Recorded in the Nelsons Clarks office I also give him one hundred dollars in Silver to him and his heirs forever then give to my daughter Betsey Floyd five Dollars having given her one recently hundred dollars in silver and three hundred in commonwealth paper then give to my daughter Polly Davis five dollars having given her recently one hundred dollars in silver and three hundred in commonwealth paper then give to my daughter Fanny Caldwell one hundred dollars in silver then give to daughter Rebecca Singleton one hundred dollars in silver then give to my daughter Kitty T. Narvey one hundred dollars in silver my will and desire is that my daughter Kitty T. Narvey shall live in my house as one of my family also three children Elizabeth William R and Gabriel M. Keene as long as she remains a widow and no longer then lend to my beloved wife Elizabeth Roberts the tract or parcel of land I now live on and all appertaining thereto in full possession so long as she lives and after her death I give it to my son John Roberts to dispose of as he may think proper by giving selling or otherwise I also give him one hundred dollars in silver to him and his heirs forever my desire is that my Grandson William Beckers shall have as much money out of my Estate as will purchase him a likely negro boy between the age of nine and twelve years and ease my Grandson should die before he comes to the age of twenty it is to be divided between his sister Elizabeth and Gabriel M. Keene I leave my unfortunate Susanna Roberts five Dollars and to be

supported out of my state as long as my wife lives and after her death a good support but of state as long as she to be in care of my wife as long as she lives I then give half of my estate to my wife Elizabeth Roberts the following property to James Rachel Jacob Betty Hannah to my young James Brister Nelson Daniel Saul Little James, Bill, Amanda Eliza and Chit America Polly and her children Greenberry Bob Jane Beards with their means forever to dispose of them as she may think proper by giving selling or otherwise I also give her all my household and kitchen furniture all my stock of horses cattle sheep and hogs waggon and Gear, blacks mits tools and all my crop that is growing of every description and all the money that may be in hand after the above legacies are paid off with all the money that is coming to my Estate by Bonds notes or accounts to dispose of as she may think proper I thought my duty to appoint my wife Elizabeth Roberts my Executor with the assistance of my son John Roberts as Co-Executor with her give under my hand and seal this the twenty sixth of July in the year of our Lord one thousand eight hundred and twenty three At winter land before signed

 had more than his proportionable part on an equal division
 that he may keep it though not to have any more. But I wish my
 Daughter Margaret Ball have retained for her in the hands
 of my Executors six hundred dollars to be put on Interest on such
 terms as will be sure to pay yearly the Interest to be paid over
 for her and his children in like manner during the life of Henry
 Ball and at his death to pay over the said sum to her if living
 and in case of her death it is to be continued at Interest until her
 (children or children) arrive at the age of eighteen years.
