Agreeably to an order of court from the Jefamius County Court to us directed bearing date January 1828 we the undersigned three of the commissioners appointed to act in and order do report as follows to wit That we met on the 31st inst at the house of Thomas Smith and all parties persons appearing before us we went in to a division of the estate and a settlement of the same with William Russell Esq- of James Sallee and Clemency Sallee formerly (but now Clemency Wilson) and report that from pouches and exhibits of said Russell presented to us we find said Russell indebted to the said Wadde the sum of five hundred and fifty dollars to the two I.C.
