William Wynn being in a state of perfect sanity of mind and believing that he should not recover from his illness under which he was then labouring, wishes his property to be disposed of in the following manner: the four negroes lowest Eddy, Mary, Eliza and Mary the youngest Mary & Eddy are to be sold five head of horses being all to be sold stand hotel kitchen furniture with the exception of a fancy bedstead and furniture, Capboard ware and a fancy chair & slip stand which are left specially to Michael Wynn his wife; the farming tools also to be disposed of. The stock of horses and cattle in partnership with Chabourn Chandler, constituting of sixty one hogs and fifteen cattle to be fattened or fed as much as may be found necessary by said Chandler the partner of said stock on the crop raised in partnership between W. Wynn and said Chandler and then to be sold and the money to be divided between the parties Chandler Wynn or Wynn Agents; The remainder of the crop after keeping said stock is to be sold and the proceeds thereof divided between the Agents or the Agents representatives and said Chandler after the payment of the rent for the farm and other contingencies as aforesaid. The cattle purchased by Chandler in the Illinois for W. Wynn and seven hogs and remaining there at pasture to be sold to the best advantage and the proceeds thereof falling to his part is to be delivered to the representative of the heirs; all the above said being made the money of the sale is to go to and is hereby bequeathed to Minerva Wynn his wife and children provided she remains single if otherwise it is (the property) to become entirely that of the children at her marriage. sundry articles which are at this time in the possession of his sister Mary Wynn are hereby willed to her, witness my seal & Test. I therefore constitute and appoint my wife Emily executrix to this my last will and testament, her heirs whom I herewith set my hand and seal this 23 day of Sept 1829.

In the name of God Amen. I James Holloway of the County of Jefferson and State of Kentucky of sound mind and memory do make this my last will and testament in the following manner: First, I desire that all my just debts be paid by my executors or her after named. I have given to my daughter Mary Bratcher one negro woman named Rachel and her increase to her and her heirs forever. I have given to my daughter Rachel one negro woman named Sally and her increase to her and her heirs forever. I have given to my son Thomas Holloway one negro boy named Ben to him and his heirs forever. I have given to my son John Holloway one negro boy named Lewis to him and his representatives forever. I have given to my daughter Martha Flournoy one negro lady named Mary and all their increase to her and her heirs forever. I have given to my son George Holloway one negro boy named Ben to him and his heirs forever. I have given to my son Samuel Holloway one negro boy named Bill to him and his representatives forever. I have given to my son Samuel Holloway all the land whereon I live at my wife's death to go rather with the house hold and kitchen furniture the farming utensils his choice of four cows six sheep one bed and bed furniture to him and his representatives forever. I have given to my wife Martha Bratcher all the land whereon I live to gather with the following negroes namely: Dick, Lucy, Mollie Jo, Peter, Robert, Eliza and Rachel and all their increase to her during her natural life to gather with all my money and stock of every description farming utensils house hold and kitchen furniture provisions and in short every article of my disposition that is not excepted to my children and my wife's death. I desire that my sons John, George, Spencer and Samuel Holloway each have the sum of two hundred dollars in value to be made out of the estate left to my wife at her death to make these negroes as valuable as the negroes I gave to my first children. I have given to my daughter Mary Bratcher two horses in consequence of which she is to have forty dollars left at the last division of the estate. I have given to my daughter Martha Bratcher one negro man more than my other children for which she is to be deducted one hundred and fifty dollars at the last division. I have given my son John Holloway one horse more than my other children for which he is to be deducted fifty dollars. I now appoint my wife and Thomas Bratcher, George, Spencer and Samuel, executors of this my last will and testament. It is my desire at my wife's death all her legacy not otherwise disposed of be divided among all my children or their heirs should any of my children die leaving no issue it is my will that their legacy or legacy return to my children given under my hand and seal this 23rd day of April in this year of our Lord eighteen hundred and twenty eight signed sealed in the presence of
