to include where he the said William now lives
and to be laid off so it has heretofore been
agreed to and the said land to stand be the same
more or less to him or his heirs forever also

I do give to my son am Southland fifty
acres of land to include the improvement that
he the said am now lives on being a part
of said tract that I bought of Colonel McDowell
and to be laid off so that the lines that has
heretofore been made and agreed to shall stand
be the same more or less to him or his heirs forever
also I do give to my son George Southland fifty
acres part of said tract adjoining to that of
amen to that of the upper side to include the
plantation I now live on and to be laid agreeable
to the former agreement to him and ~~have~~ his heirs
forever excepting a possible papercan and maintain
mow on said plantation during life for my wife
Mary Southland. I also do give to my Daughter
Theny Harbino to be paid out of my estate to her
or her heirs also to my daughter ^{Susan} ~~Susan~~ ^{Harper} ~~Harper~~
five shillings to be paid out of my estate ~~also~~
also my daughter Susan Harper five shillings to
her or her heirs also my daughter Polly Lister
five shillings to her or her heirs also I do give
to my Daughter Lenny and Nancy each of
them a good feather bed and furniture to be
about equal to the bed and furniture I gave

Polley Lewis also a good cow and calf each
a good duck and basson and half a dozen
plates of new plate each and of good
Muglin habit of a good fine quality, I to be
maintained out of estate until they may or come
to age of eighteen years the above I bequeath to
and their poster also I do with bequest to
my beloved wife Mary Southland all the remaining
part of my estate goods & chattels for and
proper use during her life and at her decease
to dispose of as she thinks proper and lastly
my I do make my trusty friend Lacey Jones an
exor or executor of this my will and to
take care and see the same performed according
to my true intent and meaning in writing & the
said William Southland have to my last will
and testament set my hand and seal the day
and year above written
