but in sound mind and memory and knowing
it is appointed for all men once to dye at this twenty
Seventh day of May in the year of our Lord one
thousand eight hundred & Seventeen and of the
Thirty first year of the Independence of the United
States of America do Herewith make & publish
this my last will and Testament in the manner
& form following. To wit, I Recommend my Soul
to god who gave it and my Body to be Buried
in a Decent Christian Burial at the Discretion
of my Executors and as for my worldly Estate
First I do Give and bequath to my beloved wife
Mary Stevenson her Body & all one Bed & Bolster
two Sheets two Blankets one Linen Bedquilt one
bow her wheel and the half of the house hold
Furniture together with a hundred Dollars paid
on John Gunber Lodges in Thomas Kell hand
in S.C. Next I Give and bequath to my Daugh-
ter Margaret Isabel one Dollar & Text I Give
and Bequath to my Son John Steel one Hundred
Dollars that he rec^d of me in South Carolina
together with a mattock & Drawing knife &
Sundry other articles at this time in his care. Next
I Give & bequath to my Daughter Sarah Boulter
thirty Dollars in money and twenty in the price of
a horse her husband Bought of me. Next I
Give & bequath to my Daughter Mary Simon Fifty
Dollars. Next I Give & Bequath to my Daughter
Martha Cunningham Fifty Dollars my new
Saddle & Bridle one Bed and all the Bed furniture
and House hold Furniture not Bequathed to my
wife together with all the Plantation tools on her
husbands premises Next I Give my Body cloth to be
Divided Equally amongst my Legates. Lastly I do here-
by constitute nominate and appoint John Ban-
ningham and John Boulter Executors of this my last
will & Testament in testimony of this being my last
will & Testament I the S. Robert Steel do hereunto
Set my hand & Seal Day & Date above writing.

I Foster I Lewis Fortner of the County of Logan and State of Kent-
ucky do make this my last will & Testament
as follows To wit I Give to my wife Mary Fortner and her
heirs forever four negroes to wit baby Jack, male and
Pamelia also two horses one called Bull the other called
Horned all the rest of my Stock to be Equally divided
between my wife Mary Fortner and my son Pleasant
except one horse called doer - I Give to my wife Mary Fort-
ner all my House Hold and Kitchen Furniture except my
case of Bottles which I Give to my son Pleasant Fortner
I Give to my son Joseph Fortner one Dollar. I Give
to my son Thomas Fortner one negro by the name of
Martin I Give to the Heirs of my son Lewis Fortner
one negro woman by the name of Matty which my son
Lewis had in possession Before his death. I Give to
my Daughter Sally Fortner one dollar. I Give to my son
porter Fortner one track of land bounded as follows to wit
beginning where my South line crosses the branch that
runs by his house running Down S. Branch till it
strikes the river thence down the river until it strikes
my lower line thence crossing the river to my corner
thence with my line to my beginning thence to the begin-
ing on the branch I Give to my son porter Fortner one
negro boy by the name of Tom I Give to my Daugh-
ter Princy Roland one negro Boy by the name of Jack
I Give to my Daughter Patsy Graham one negro Girl
by the name of Franky I Give to my Daughter
Susanna Bingham one negro Boy by the name
of Jacob. I Give to my Daughter Vilet Lawrence
one negro woman by the name of Miller. I Give
to my Daughter Jan Tanner one negro Child by the
name of Kelley. I Give to my wife Mary Fortner
one negro man by the name of Stafford for three
years and then I Give the old negro to my son
Pleasant Fortner. I Give to my son Pleasant Fort-
ner one negro by the name of Ann my the land
I now live except what I Give to my son porter

I give to my wife Mary Fortner her life time except the field where Pleasant Fortner is building his house and the one where I had wheat and oats in this summer which this field I give to my son Pleasant Fortner likewise all the Land I gave my wife her life time I give to my son Pleasant Fortner I give all my plantation tools to my wife Mary Fortner and my son Pleasant Fortner my will and desire is that my waggon and one horse called doctor be sold to pay my debts the crop now growing I give to my wife Mary Fortner I do hereby appoint Spencer Burd and John Burd Executors to this my last will & testament, as witness my hand this twenty second day of July 1818.
