

In the name of God, Amen, I Henry, Wells of
 Logan County, State of Kentucky, being weak in
 body but of sound and disposing mind and
 memory, Calling to mind the mortality of my body
 knowing that it is appointed for all men once to die,
 do make and ordain this my last will and testament
 Viz, First I commend my soul to the hands of God
 who gave it and my body to be buried in a Christian
 manner at the discretion of my friends & relations and
 as touching such worldly estate whereof I have
 pleased God to be so free, with it to dispose of as
 follows Viz, After the payment of my just debts
 and funeral charges I leave 1st I will bequeath to
 my beloved wife Catharine Wells my Negro
 Robt, Sarah, Ben, Fred and Solomon & Solomon
 together with the plantation during his natural
 life and all the stock of horses cattle pigs sheep
 &c. &c. except the store that David Snow claims
 Viz a brown horse docked with all the household
 and kitchen furniture and the present crop of
 every description added at her death to be divided
 as follows Viz to my son Thomas Wells 1/3 my
 negro man Lewis to my son David Wells 1/3 & give
 & bequeath the plantation or tract of land
 whereon I now live together with my negroes Robt
 Sarah and Solomon and the stock to my son
 sonny Wells until the sum of fifty dollars
 and to my daughter Polly Wells fifty dollars and
 to my daughter Nancy Barclay fifty dollars to be
 paid at his own discretion and to my son John Wells
 I give my negro boy & Simon and to my son Jonathan
 Wells I give my negro woman Luc and it is my
 will that each of the last named John &
 Jonathan have one bed and furniture and the
 whole of my stock of horses cattle pigs sheep &c
 &c. &c. together with my household and kitchen
 furniture at the discretion of my wife Catharine
 be equally divided between my three sons John
 David & David according to the share each
 of them is to have, I Henry Wells do hereby
 certify that I am of sound mind and memory
 and of my property therefore I shall allow this my
 last will & testament to be signed by me lastly I
 do hereby constitute and appoint my son David
 Wells Charles to Robert Davidson of the my last will
 and testament and do hereby revoke and disannul
 all former wills & testaments volitions and confirmings
 this to be my last will & testament to which

whereof I have herewith set my hand and seal the nineteenth day of June 1824
Signed sealed and acknowledged in presence of
Clayton Lockart Henry Wells

before me this 21st of June 1824 at a County Court held
for said County at the Court House in Russellville on
the 5th day of July 1824 the Jurors, Carlwell and
testament of Henry Wells did say, produced in open
Court & proved by the oaths of Clayton Lockart and
William P. Galtale two of the said County Jurors
true, and to be recorded, where to together
with the true original County duly recorded in my
Office the testimony of a true & lawful set my hand
the date above.
