County Kentucky being Weak no body but of sound &
perfect mind and memory considering the uncertainty
of the mortal life do make publick and declare
this my last Will and Testament in manner and
form following that is to say after my last debt or
debts I give and bequeath to my eldest daughter
Martha Ann Dibble a yellow Girl about 18 years of
age by name Fann and all her molder and all
the part of a tract of land I have on the waters
of Dranes Creek according when Sirrums was
called the Royal place to include the plantation say
one hundred acres or perhaps more as it is to be land
of no good form which is to be reserved for
Samuel De Miller after the reserve the balance
supposed to be about five hundred acres to best
the heir of her body forever in like manner I
give her Fiddlers hundred dollars which she has
received and cash and in a negro boy named
Cyrus which reference can be made to the receipt
showing that I gave to my daughter Fann and De Miller
four negroes namely Oliver and her child Nancy
Simmons about 18 years old and affix a negro boy
about that time age the reserve part of land which
Sirrums lives the Royal place and the slaves placed
to her and the heir of her body forever
thence my wish is that my Chertown Land be
divided as follows that Cyrus Davis have his share
in the four quarter sections say one quarter section
with one hundred acres of United States Money
he and me and that Napoleon G Davis and
Joseph Davis have the other four quarter sections
Equally divided between them
thence I give and bequeath to Cyrus Davis the
Royal plantation and the Richmonds place on the
waters of after creek and a negro boy named George
Duff that I gave to Joseph Davis my own property
with the agreement that and the whole plantation
containing one hundred & sixty acres and a
negro boy named Ned
I bequeath them to my beloved wife Polly Davis the
residue of my real and personal estate say the

plantations which I now live and the Union place con-
taining about ten hundred acres with my bank stock and
her life or widowhood and at her death or marriage my
will and desire is that Napoleon G Davis have the share
I have on with the Union place as well as to my wife after
the death or marriage of his mother and a negro boy
named Adam and that Napoleon be answerable for and
Furnish of my beloved wife and to be kept at school till
he arrives at age out of the profits arising out of the
two plantations namely the share on which I have two
and the Union place
thence my bank stock after the death or marriage of
my wife to be equally divided between my five
children namely Cyrus Joseph Martha Fann and
Napoleon
thence my negroes not mentioned in the will
with the personal property in the possession of my wife
at her death or marriage to be equally between
my three sons Cyrus Joseph & Davis and
Napoleon G Davis
thence I hereby empower by and G Davis and Joseph
Davis to make deed to all my land that is sold and
not deeded let also I appoint them executors to the
within mentioned will thence I have set my
house and affix my seal this 17th day of March one
thousand eight and twenty three

is 25 years old In as much when I had been
